CORPORATION WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,, That in consideration of FOUR HUNDRED TWENTY TWO THOUSAND FOUR HUNDRED THIRTY FOUR AND 00/100 DOLLARS (\$422,434.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Clayton Properties Group, Inc., a TN corporation (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Lisa G. Klamer, an unmarried woman (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:

Lot B-121, according to the Survey of Griffin Park at Eagle Point, Sector 2, Phase 2A, as recorded in Map Book 53, Page 23 A&B, in the Probate Office of Shelby County, Alabama.

SUBJECT TO: (1) Ad valorem taxes for current and subsequent years, (2) easements, restrictions reservations, rights-of-way, limitations, covenants and conditions of record, if any, (3) mineral and mining rights not owned by the Grantor, if any

TO HAVE AND TO HOLD, to the said GRANTEE, her heirs and assigns forever.

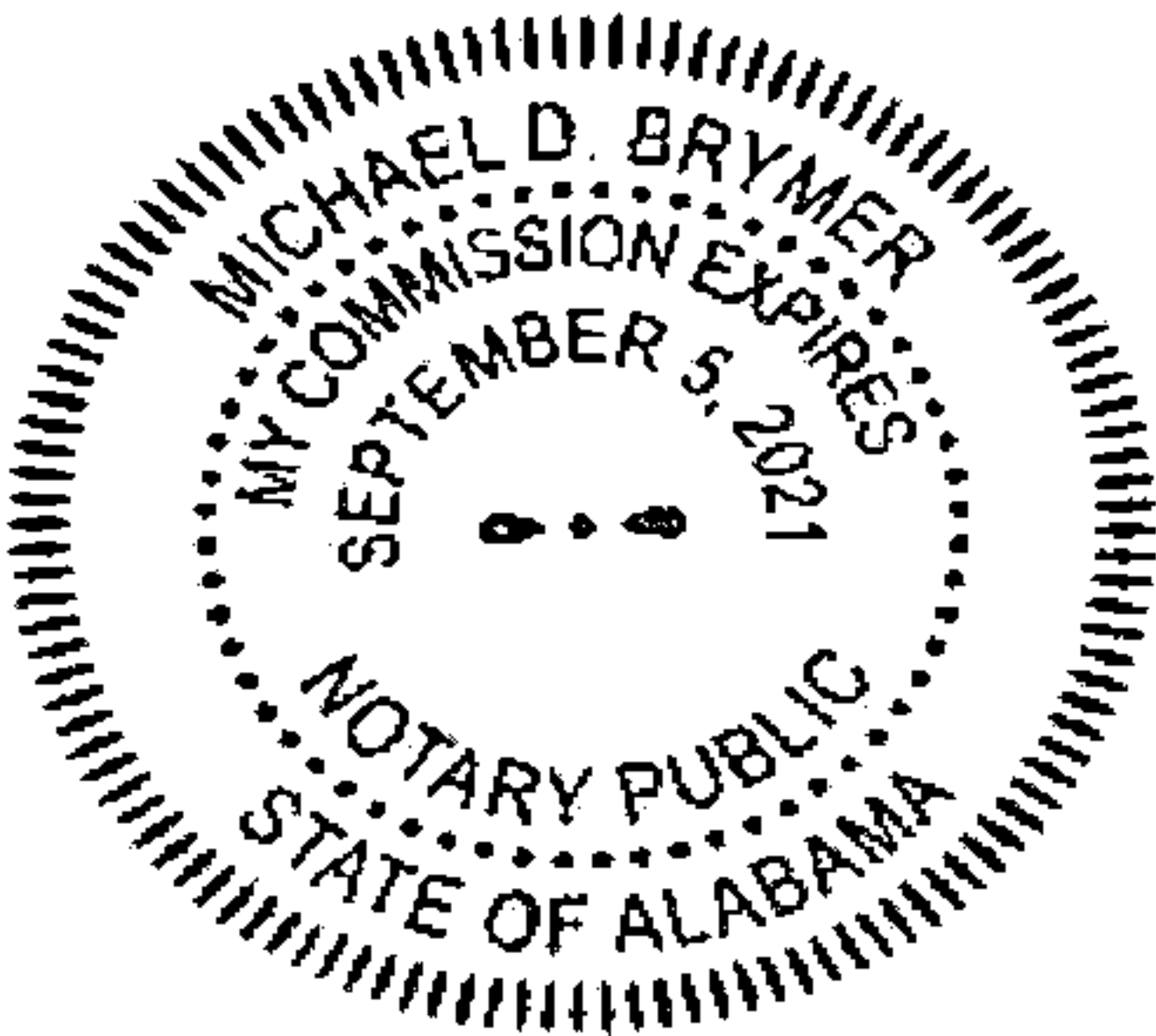




