WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this August 16, 2021, That for and in consideration of **FIVE HUNDRED NINETY TWO THOUSAND AND NO/100 (\$592,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **ERNEST L. WILLIAMS and MARY H. WILLIAMS**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **HANNAH L. CATALFU and CRAIG CATALFU**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 14 according to the Survey of Stonebrook as recorded in Map Book 15, Page 114, Shelby County, Alabama Records.

Subject to:

7. Restrictions filed of record in Book 384, Page 152.

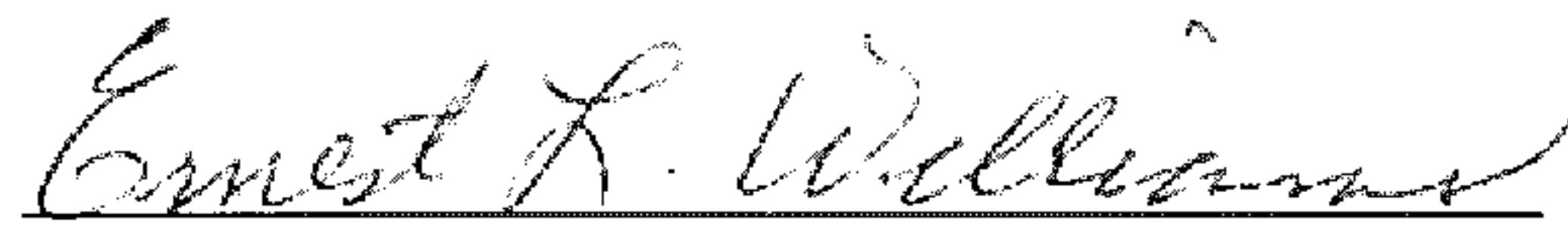
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

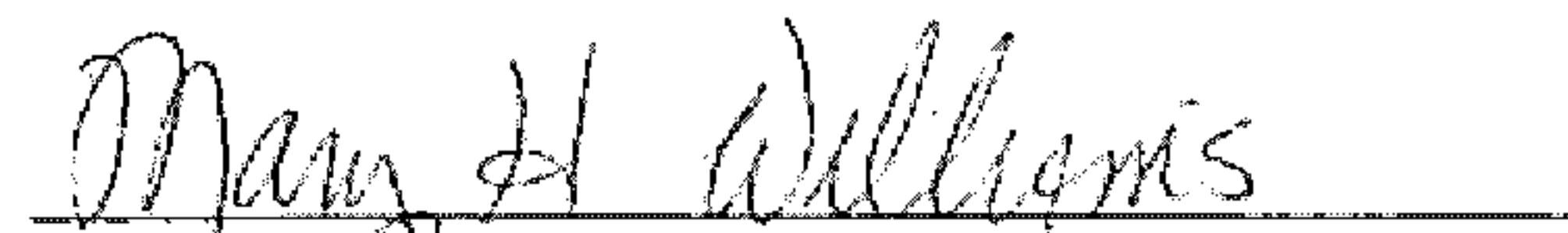

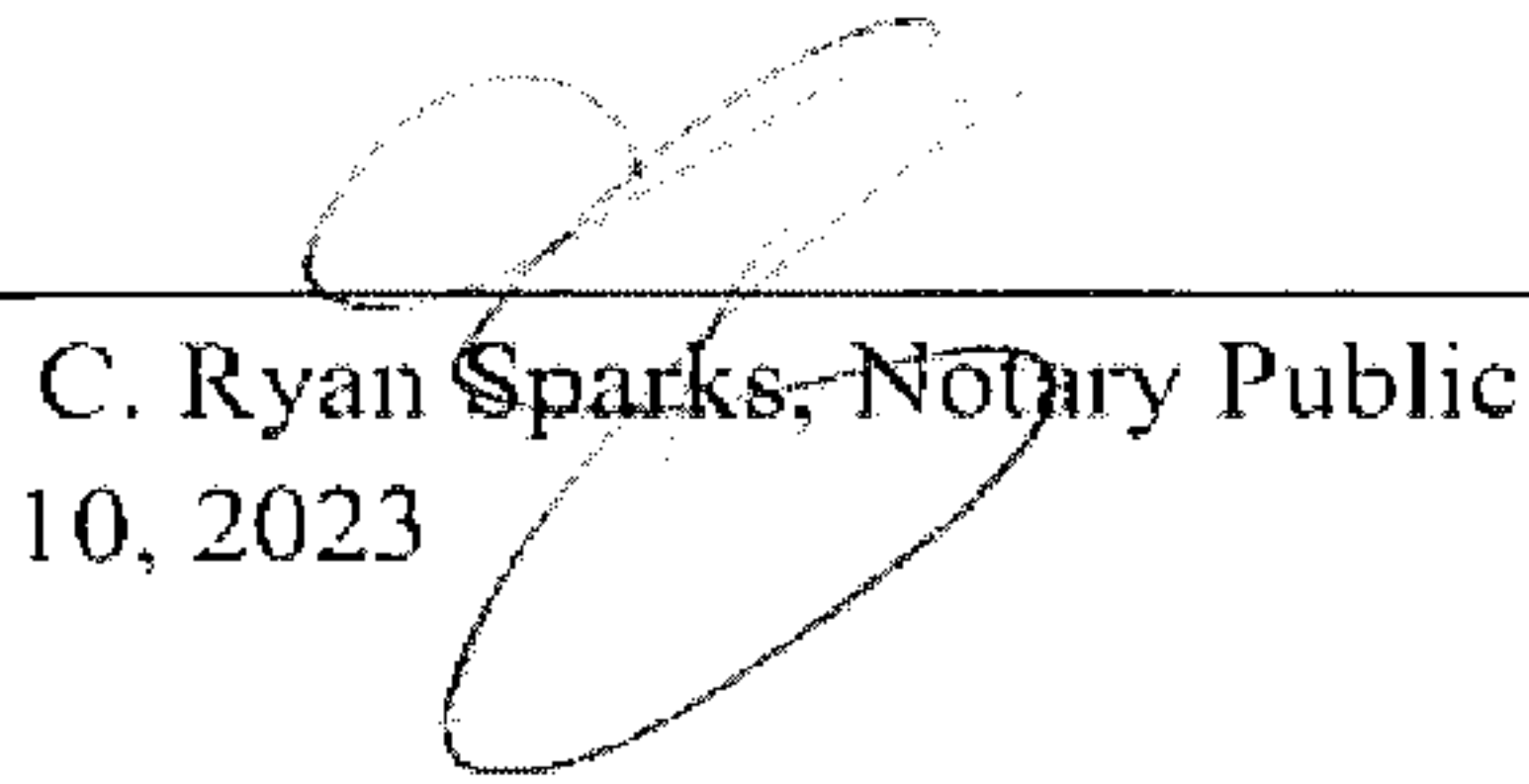
