That in consideration of **Ten and 00/100 Dollars (\$10.00)** and other good and valuable consideration to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:







