

Last Will and Testament

THIRD: If my said wife shall predecease me, or if my wife and I shall die in a common accident or disaster, or if my wife shall not survive my demise by ninety (90) days, then, and in either of such events, I hereby direct that all of my above-mentioned property be divided equally between the following:

- A. My daughter, **KATHLEEN MARIE FLOW SHULEVA**, residing at the time of this writing in Vestavia Hills, Alabama,
- B. My son, **FRANK JOSEPH FLOW III**, residing at the time of this writing in Alabaster, Alabama, and
- C. My son, **TIMOTHY LAWRENCE FLOW**, residing at the time of this writing in Brecksville, Ohio,

in equal shares, **per stirpes** and not **per capita**, to be theirs absolutely, to have and to hold, in fee simple forever. Provided further, that in the event any of my abovesaid children predecease me, leaving issue, then I hereby direct that said deceased child's share be
