KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 25th day of July, 2013, CANDACE C KNIGHT AND BRIAN KNIGHT, WIFE AND HUSBAND executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS MORTGAGEE, AS NOMINEE FOR NATIONAL BANK OF COMMERCE, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on July 30, 2013, at Instrument Number 20130730000309040, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to PROVIDENT FUNDING ASSOCIATES, L.P., by instrument recorded in at Instrument Number 20180322000095060, in the aforesaid Probate Office ("Transferee"); and
