(herein referred to as grantees) as joint tenants with right of survivorship, the following described real estate property situated in Shelby County, Alabama, the address of which is: 151 Scarlet Oak Dr., Alabaster, AL 35114 to-wit:



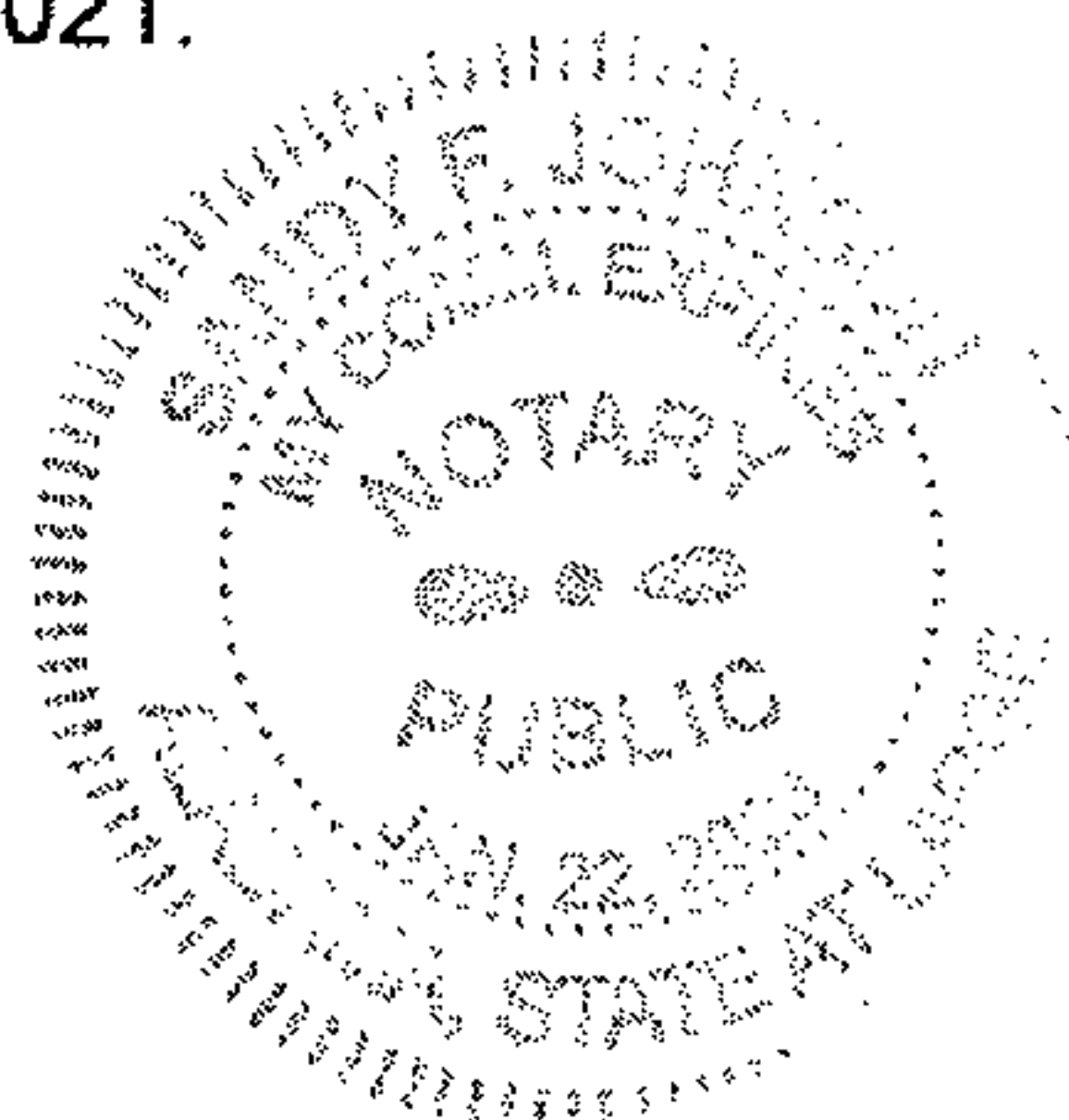
