WITNESSETH, that

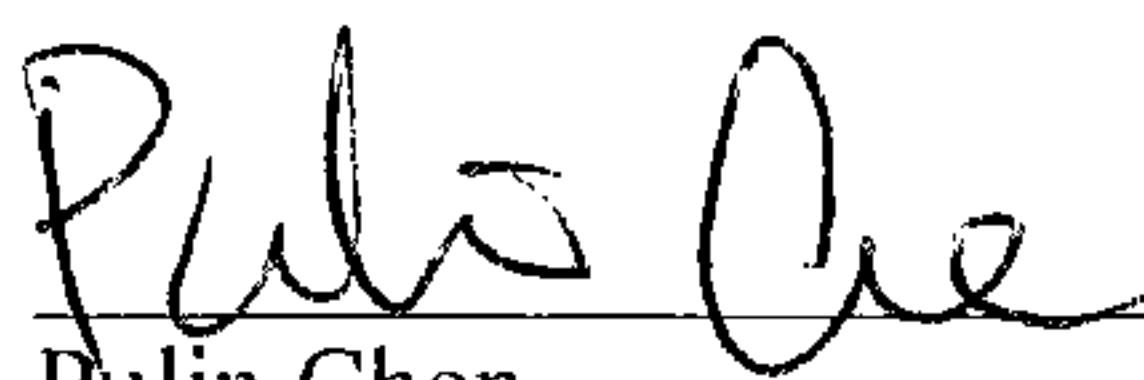

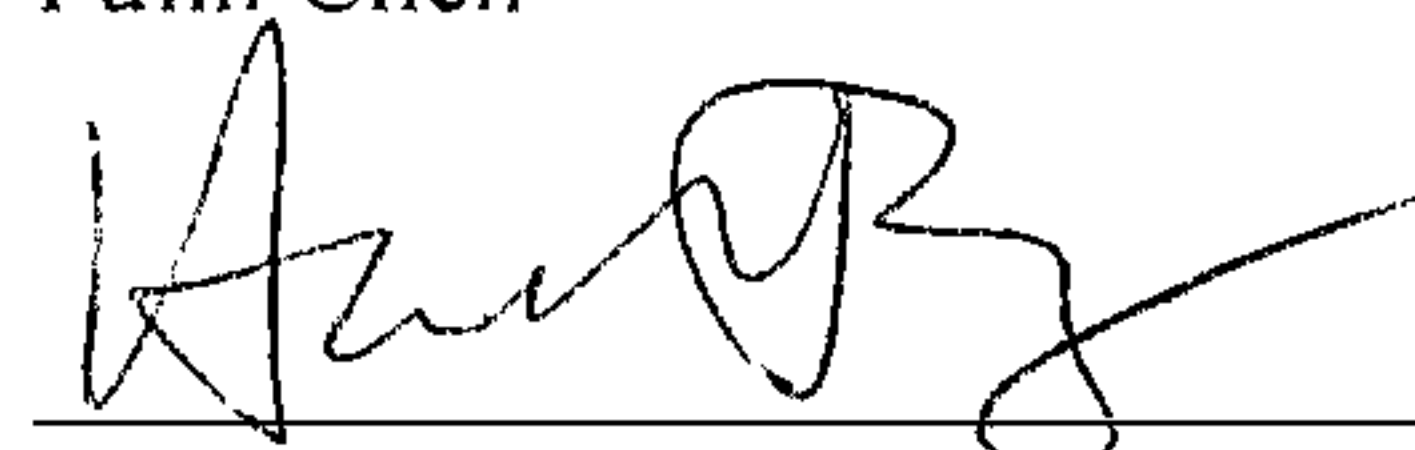
