KNOW ALL MEN BY THESE PRESENTS,, That in consideration of THREE HUNDRED NINE THOUSAND SEVEN HUNDRED FIVE AND 00/100 DOLLARS (\$309,705.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Clayton Properties Group, Inc., a TN corporation (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Amanda DeLane Holloway, an unmarried woman (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:

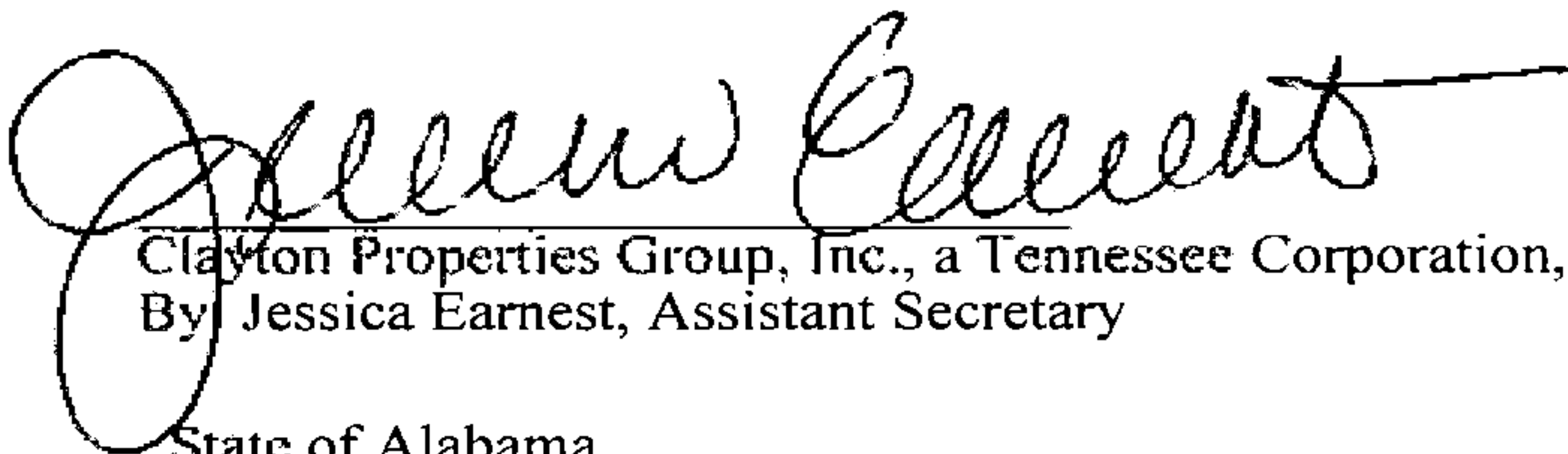
Note: \$278,734.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

TO HAVE AND TO HOLD, to the said GRANTEE, her heirs and assigns forever.

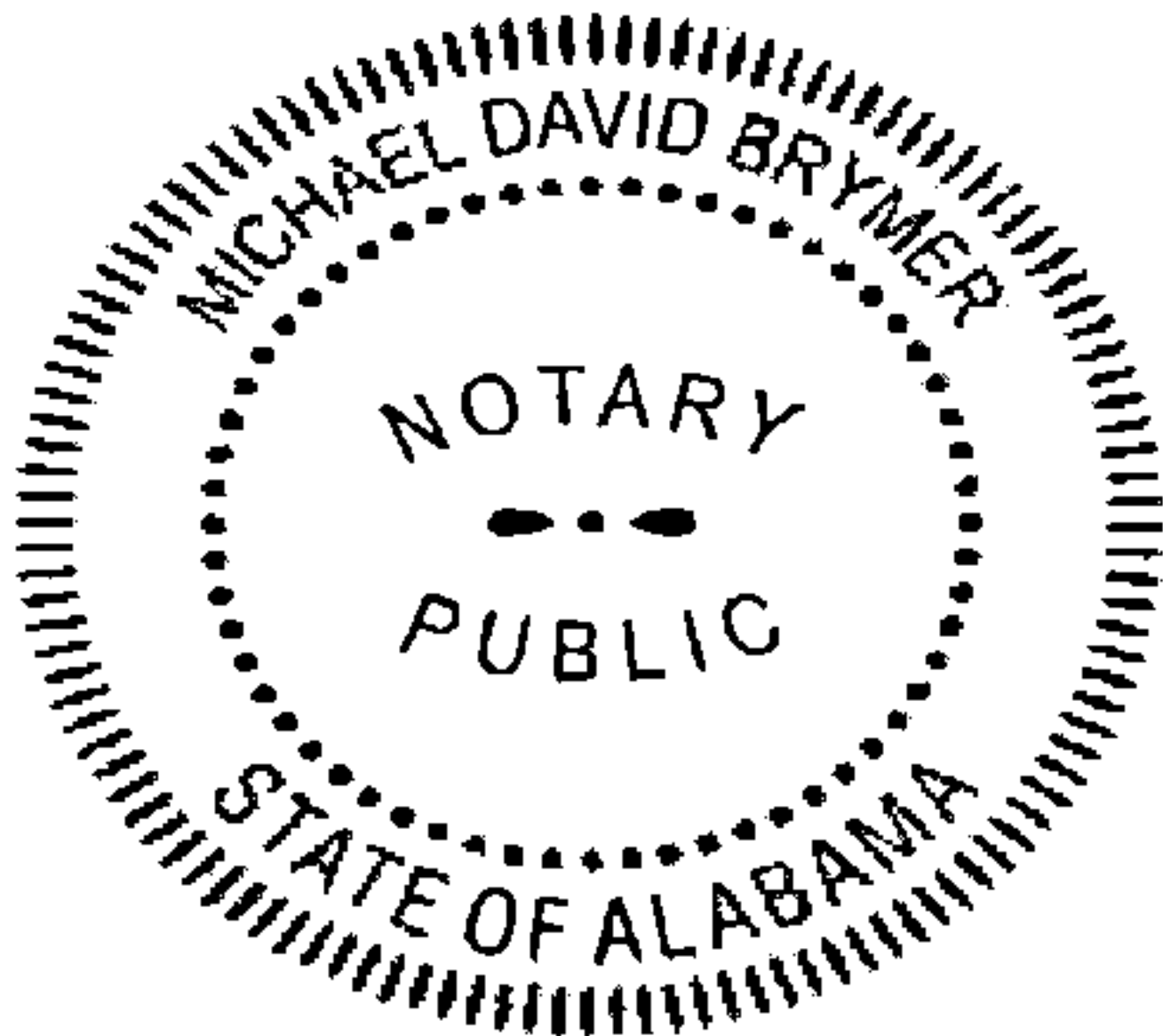

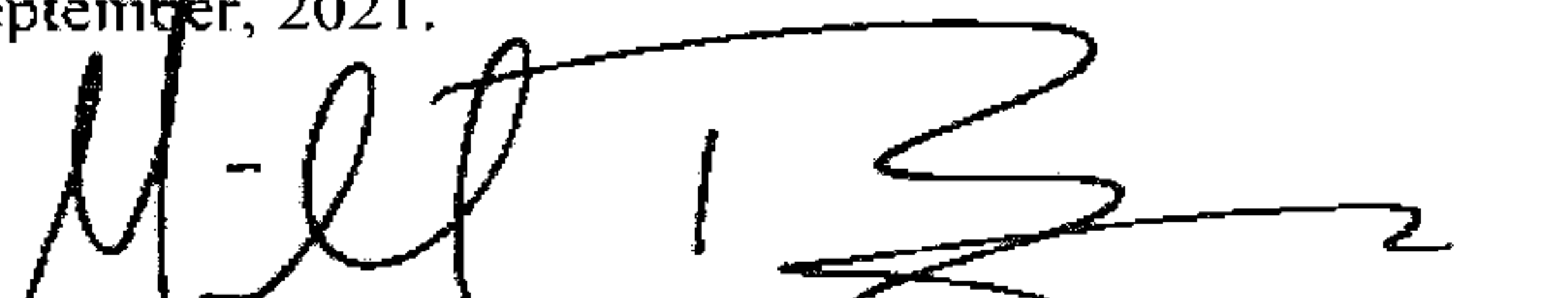

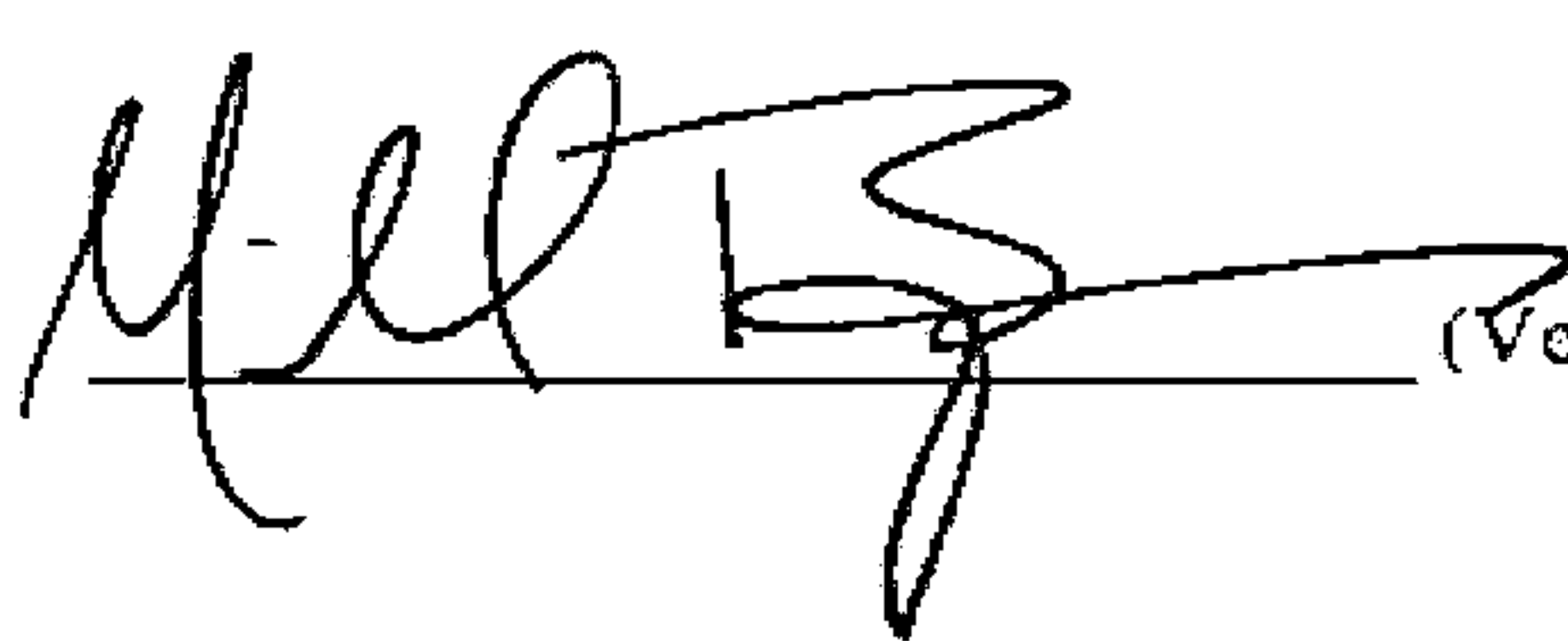
