3. The present Trustees of the Trust (the "Trustees") are:

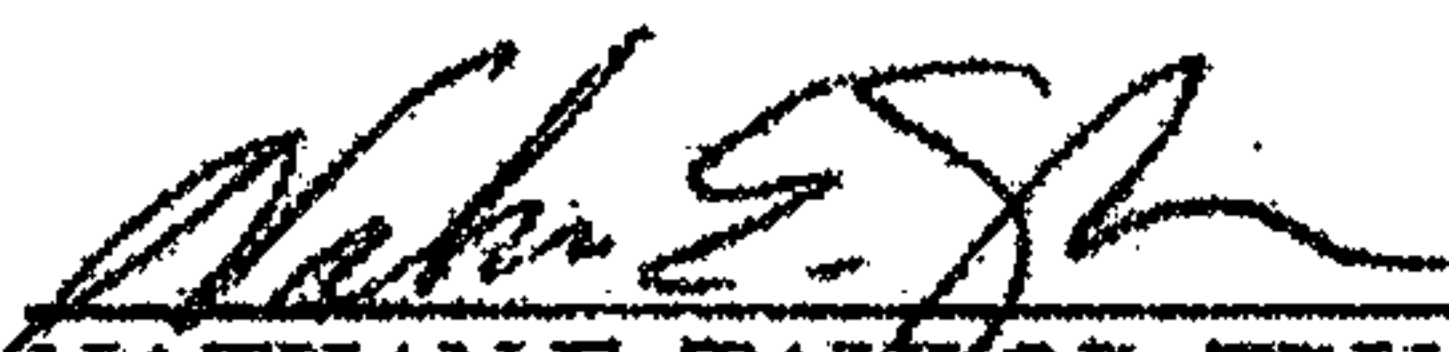

5. The Trust is a **REVOCABLE** trust. Any person holding the power of revocation is named below:

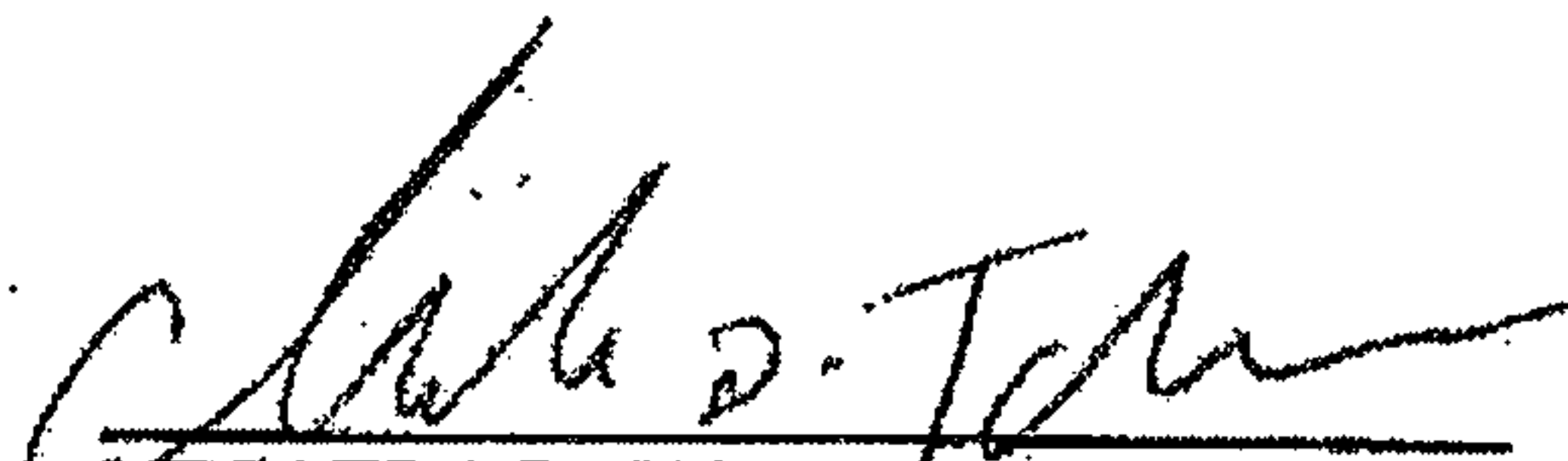

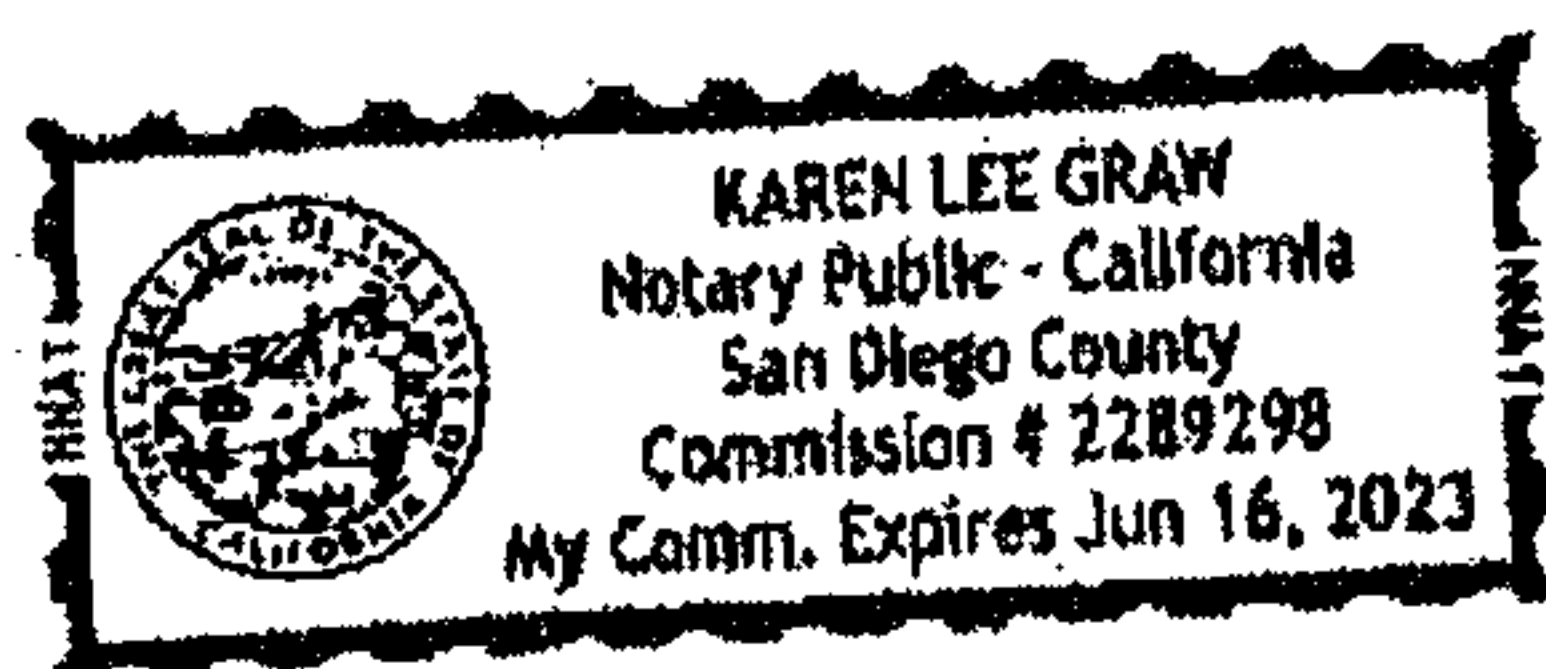
