WHEREAS, Allison Lauren Clemmons, also known as Allison Clemmons, was appointed as the Personal Representative of the Last Will and Testament of Reba Clemmons, AKA reba Snow Clemmons, deceased, and was granted Letters of Testamentary by the Probate Judge of Shelby County, Alabama, on August 26, 2020, and has duly qualified as said Personal Representative, and is now acting in the capacity of said Personal Representative, and

WHEREAS, the said Last Will and Testament of Reba Clemmons, AKA Reba Snow Clemmons, deceased, grants the power to sell and convey by the said Personal Representative, Allison Clemmons, also known as Allison Lauren Clemmons, and

WHEREAS, That the Paragraphs of "FAMILY" and "PRIMARY REMAINDER BENEFICIARIES" within the Last Will and Testament of Reba Clemmons, AKA Reba Snow Clemmons, deceased, provides for a devise of real property to Allison Lauren Clemmons, as described in the Last Will and Testament as follows: FAMILY: At the time of executing this Will, I am unmarried. Unless otherwise indicated in my Will, the shares allocated to my children and the issue of my deceased children will be distributed to these beneficiaries, outright and free of trust. The terms "issue," "child," "childern," include a person who has a parent-child relationship, as defined under applicable state law, with the person through whom this person claims benefits under my Will. These terms do include persons who are adults at the time of adoption. ;and

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES, and the sum of Ten Dollars and No/Cents (\$10.00) and other good and valuable consideration, to the undersigned grantor, in hand paid by the grantee herein, the receipt whereof is hereby acknowledged, I Allison Lauren Clemmons, also known as Allison Clemmons, as the Personal Representative of the Estate of Reba Snow Clemmons, AKA Reba Clemmons and Reba S. Clemmons, deceased (herein referred to as grantor), do in my representative capacity as said Personal Representative, grant, bargain, sell and convey unto, Allison Lauren Clemmons, an unmarried woman, (herein referred to as grantee), the following described real estate, situated in Shelby County, Alabama and as described as follows: Lot 2-58, according to the Plat of Chelsea Park 2<sup>nd</sup> Sector as recorded in Map Book 34, Page 22 in the Probate Office of Shelby County, Alabama.


