WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Two Hundred Seventy Thousand and 00/100 Dollars (\$270,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

Madison Ann Ford, an unmarried person

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Gregory Craig Zeitlin and Chyrel LaRue Zeitlin

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 81, according to the Amended Plat Shelby Farms Subdivision, as recorded in Map Book 46, Page 5, in the Probate Office of Shelby County, Alabama.

\$210,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

 (3) all easements, rights-of-way, restrictions, covenants and
 encumbrances of record.

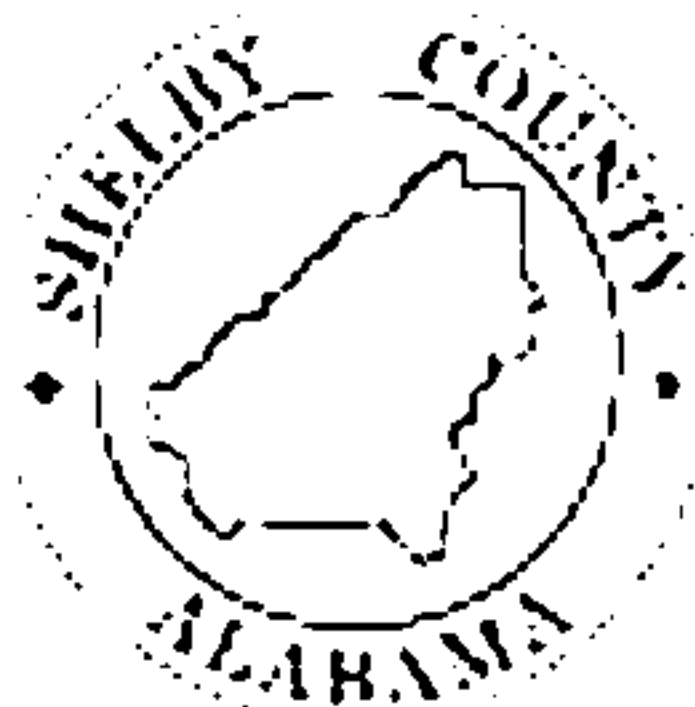
