Hopkins and Chantal Hopkins**, (herein referred to as Grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

SUBJECT TO ALL MATTERS OF RECORD

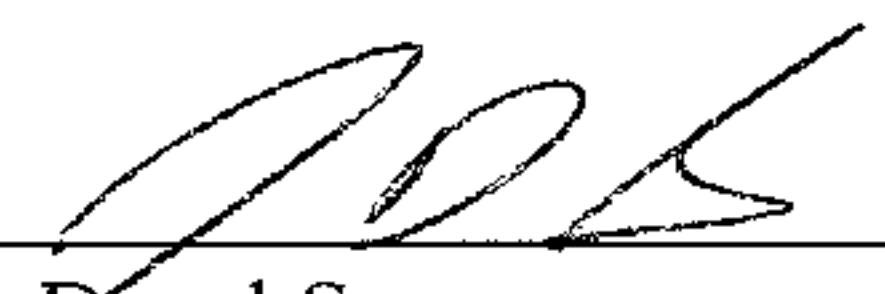
\$658,500.00 of the purchase price recited above has been paid from the proceeds of a mortgage loan closed simultaneously herewith.

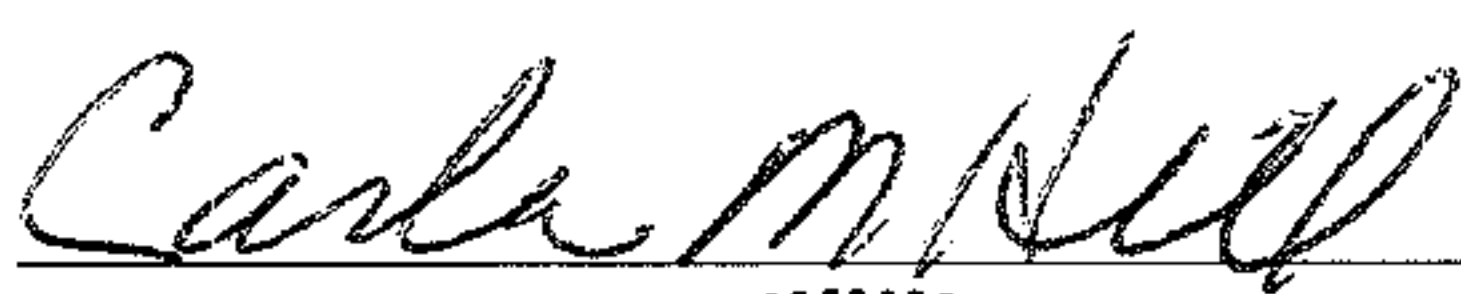

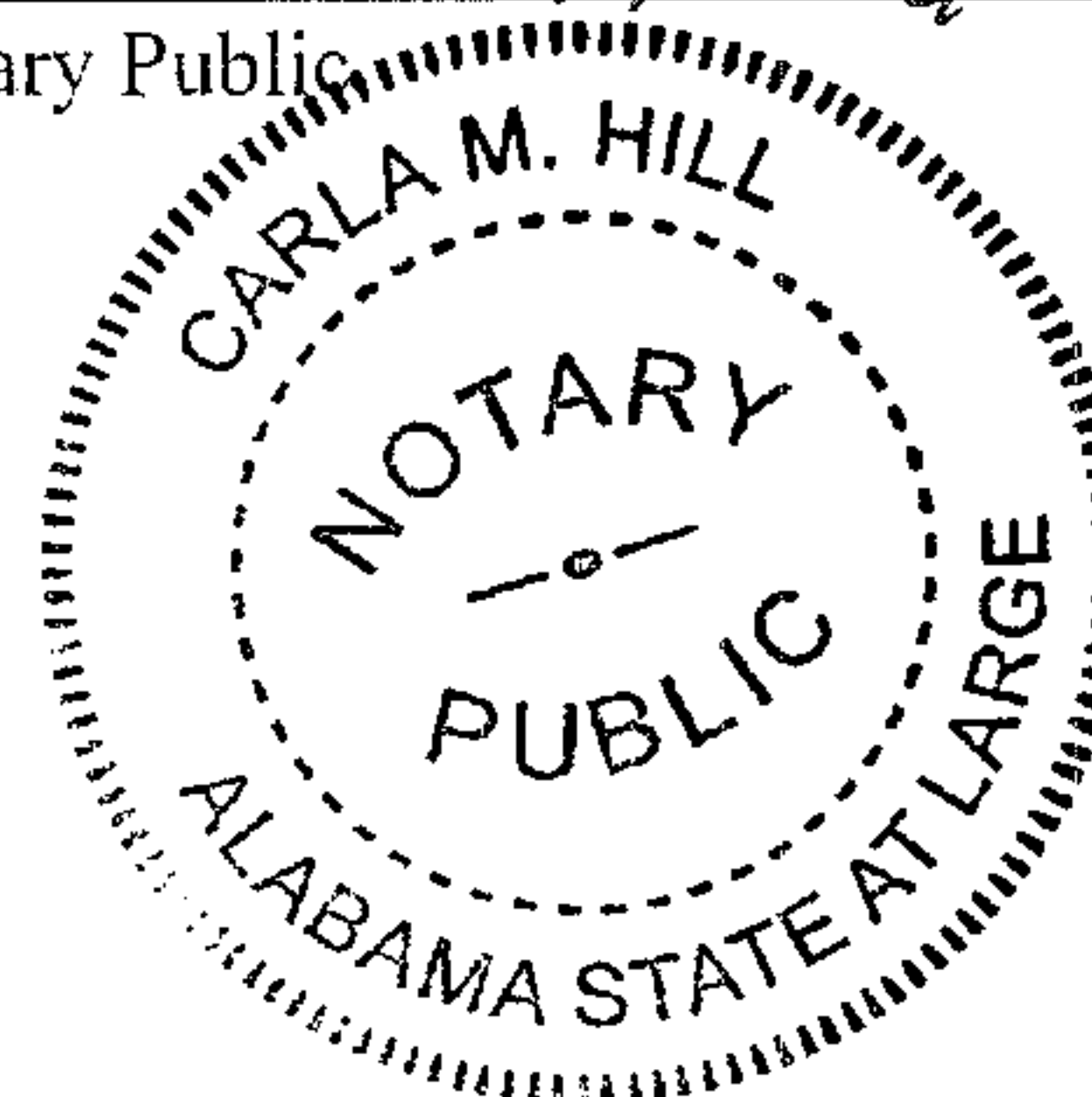
