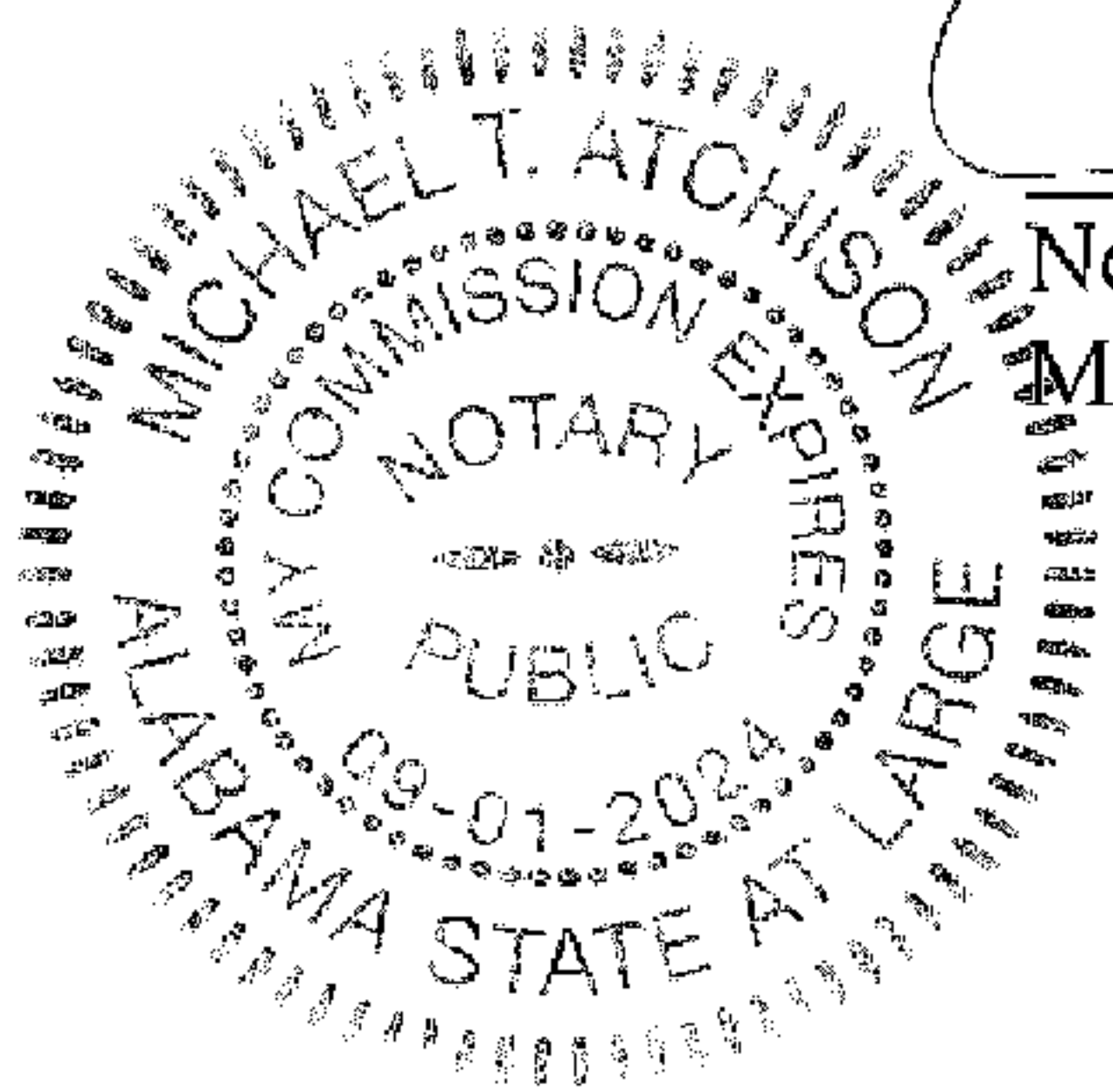

BEGIN at the SW Corner of the NE 1/4 of the NW 1/4 of Section 10, Township 21 South, Range 2 West, Shelby County, Alabama, said point being the POINT OF BEGINNING; thence N88°17'24"W for a distance of 212.76' to the Easterly R.O.W. line of Shady Road and a curve to the right, having a radius of 295.00, and subtended by a chord bearing of N35°46'36"E, and a chord distance of 39.93'; thence along the arc of said curve and along said R.O.W. line for a distance of 39.96' thence N39°39'27"E and along said R.O.W. line for a distance of 73.57' to a curve to the left, having a radius of 530.00', and subtended by a chord bearing of N28°32'37"E, and a chord distance of 204.32'; thence along the arc of said curve and along said R.O.W. line for a distance of 205.61' to a compound curve to the left having a radius of 1005.00', and subtended by a chord bearing of N06°46'18"E, and a chord distance of 292.93'; thence along the arc of said curve and along said R.O.W. line for a distance of 293.97' to a point on the R.O.W. line that changes from Shady Road to Crasscut Road and a compound curve to the left, having a radius of 330.00', and subtended by a chord bearing of N04°06'02"W, and a chord distance of 28.70'; thence along the arc of said curve and along said R.O.W. line for a distance of 28.71'; thence N08°35'35"W and along said R.O.W. line for a distance of 62.95' to a curve to the right, having a radius of 670.00', and subtended by a chord bearing of N03°04'12"E, and a chord distance of 204.71'; thence along the arc of said curve and along said R.O.W. line for a distance of 205.51'; thence S89°55'27"E and leaving said R.O.W. line for a distance of 956.02'; thence S00°06'17"W for a distance of 888.30'; thence N88°17'24"W for a distance of 946.31' to the POINT OF BEGINNING.
