SUBJECT TO:

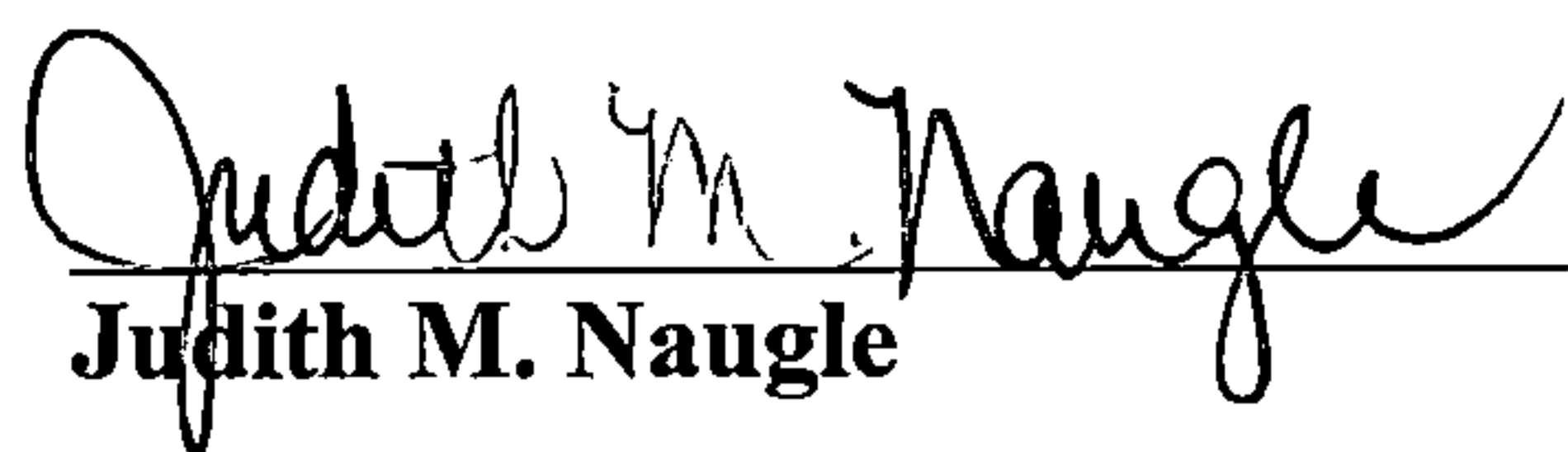
1. Ad valorem taxes due and payable October 1, 2021.

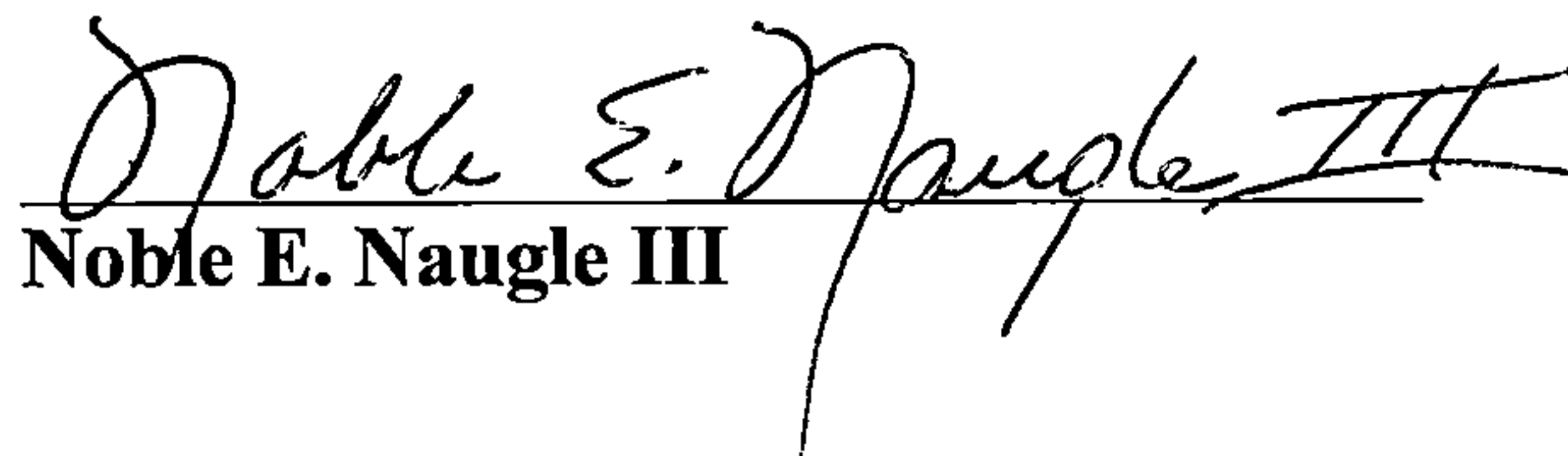
The purpose of this deed is to correct the Lot # as shown on instrument recorded in Instrument #20200921000422150, Shelby County, Alabama.

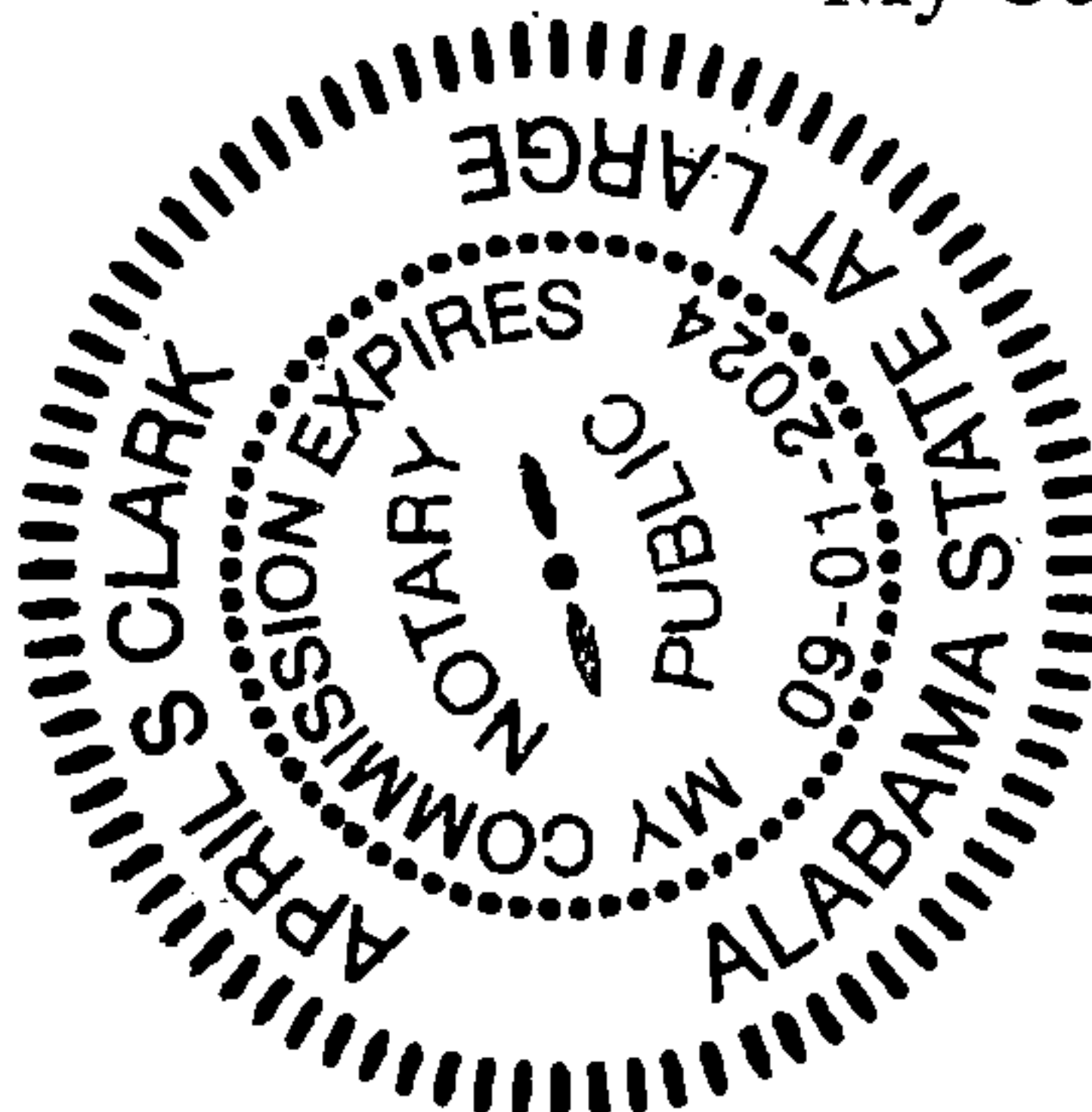
