WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **FIVE HUNDRED FORTY FIVE THOUSAND AND 00/100 Dollars (\$545,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

David Ray Faber, II and Karen Croninger Faber, a married couple

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Paul Robert Edmunds and Tracy Sanders Edmunds

(hereinafter referred to as "Grantees"), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 46, according to the Survey of High Chaparral, Sector 3, as recorded in Map Book 25, Page 83, in the Probate Office of Shelby County, Alabama.

\$430,550.00 of the proceeds come from a mortgage recorded simultaneously herewith.

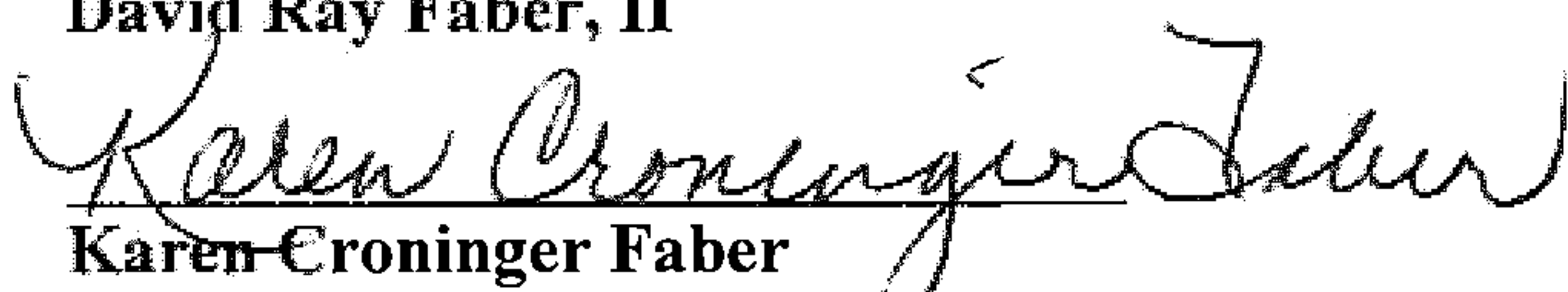
Subject to: (1) 2021 ad valorem taxes not yet due and payable;

(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

And we do for ourselves and for our heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

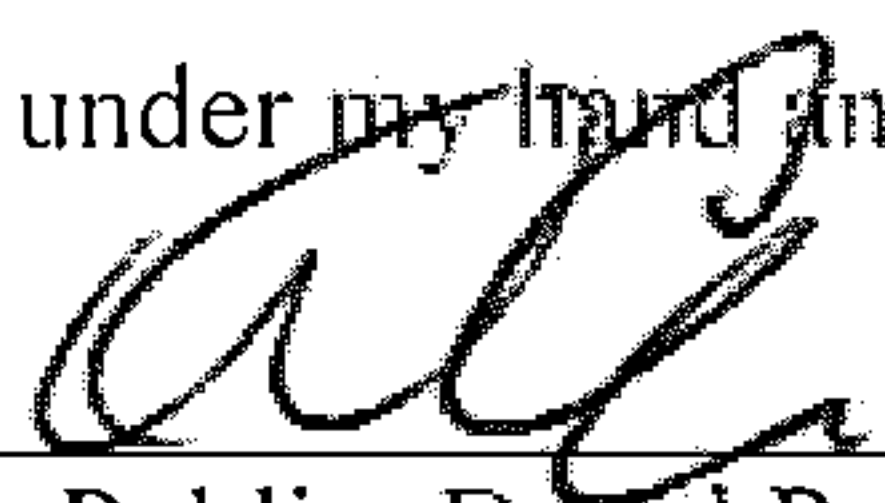

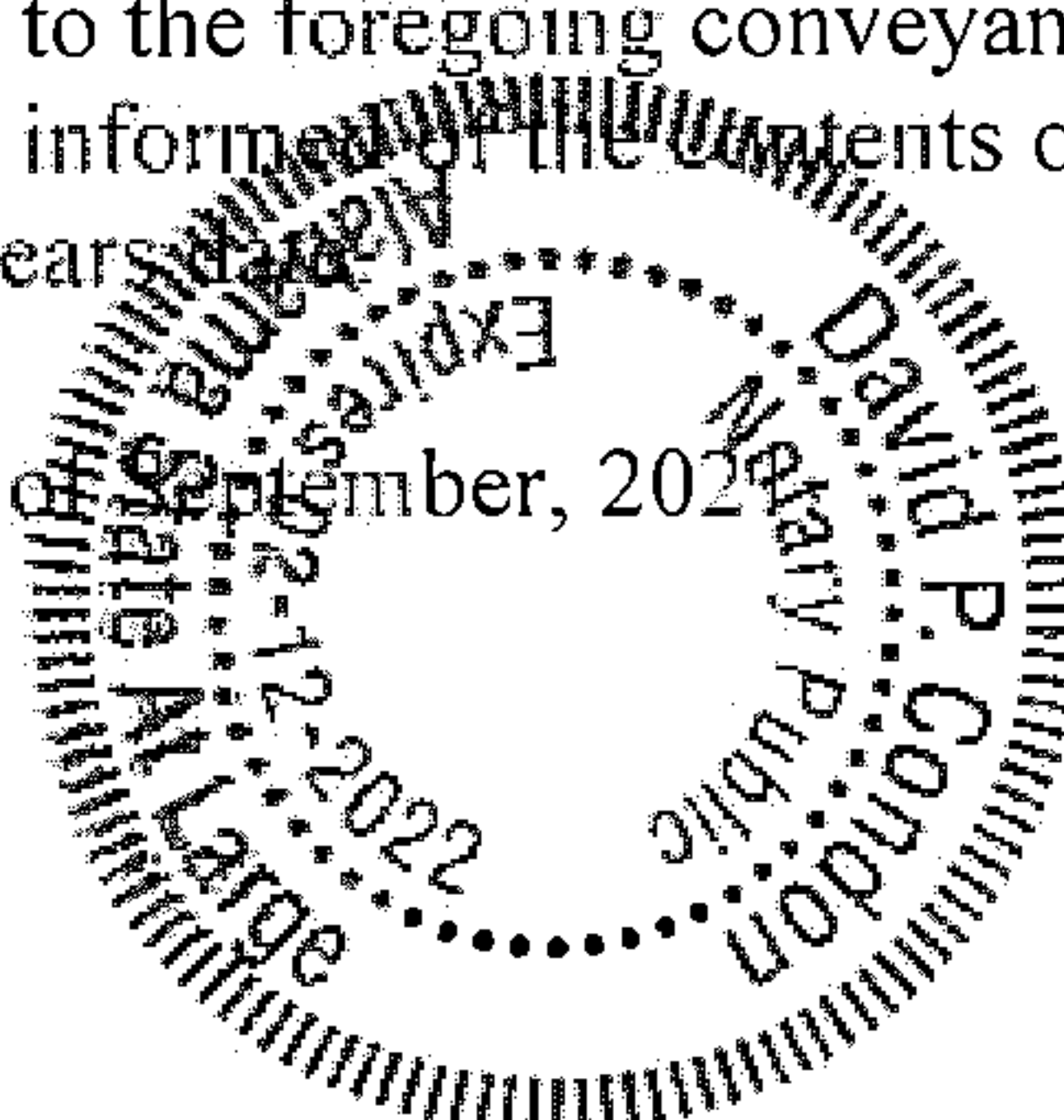

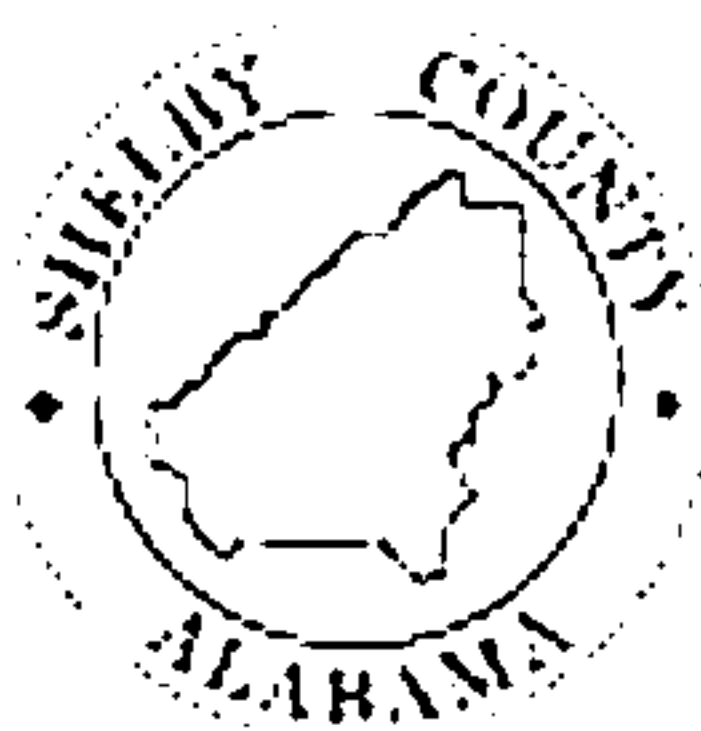
