**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Ten and 00/100 Dollars (\$10.00)** and other good and valuable consideration to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

**James L. Kitchens, an unmarried person**

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

**James L. Kitchens and Annette G. Bigham**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

**Lot 21, according to the Survey of Little Oak Ridge Estates Second Sector, as recorded in Map Book 5, Page 39, in the Probate Office of Shelby County, Alabama.**

Subject to: (1) 2022 ad valorem taxes not yet due and payable;  
(2) all mineral and mining rights not owned by the Grantor; and  
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.




