COME NOW, Dan E. Hope and Leslie Wayne Hope, as "Affiants" herein, and after first having been duly sworn, said Affiants do hereby depose and say as follows:

1. Affiant, Dan E. Hope, hereby acknowledges and confirms that he has personal knowledge of the facts stated herein, is over the age of 19 years, competent to execute this Affidavit, and his current address is 3769 Hwy 71 Shelby AL 35143. Said Affiant further states that he has no pecuniary or other interest in the estate of Elmer Carden and/or Elner Mae Glass.
2. Affiant, Leslie Wayne Hope, hereby acknowledges and confirms that he has personal knowledge of the facts stated herein, is over the age of 19 years, competent to execute this Affidavit, and his current address is 6639 Co Rd 51 Clanton, AL 36046. Said Affiant further states that he has no pecuniary or other interest in the estate of Elmer Carden and/or Elner Mae Glass.
3. Said Affiants hereby state that they are personally familiar with the family history of Elmer Carden, and hereby acknowledge and confirm that Elmer Carden died on December 31, 1978.
4. Elmer Carden was unmarried at the time of his decease, and was survived by one child, Elner Mae Glass. Said child was the only next-of-kin and heir-at-law of Elmer Carden. At the time of death of Elmer Carden, Elner Mae Glass was over the age of nineteen (19) years, and, to the knowledge of the Affiants, of sound mind.
5. Said Affiants hereby state that they are personally familiar with the family history of Elner Mae Glass, and hereby acknowledge and confirm that Elner Mae Glass died on January 24, 2016.
6. Elner Mae Glass was survived by her spouse, Billy Joe Glass, and two children, Billy Ray Glass and Patrick Steven Glass. Said spouse and children were the only next-of-

FURTHERMORE, the Affiants saith naught.



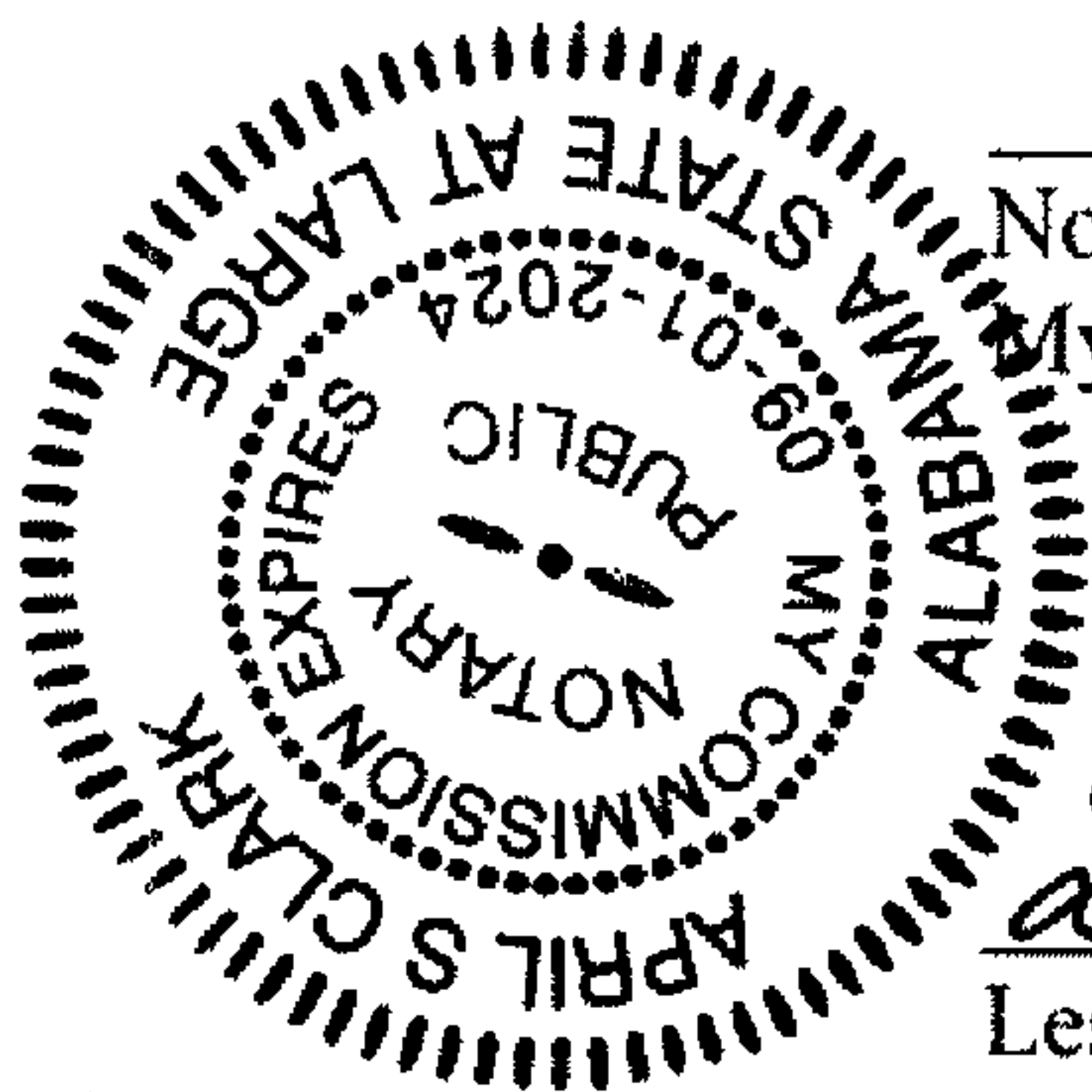

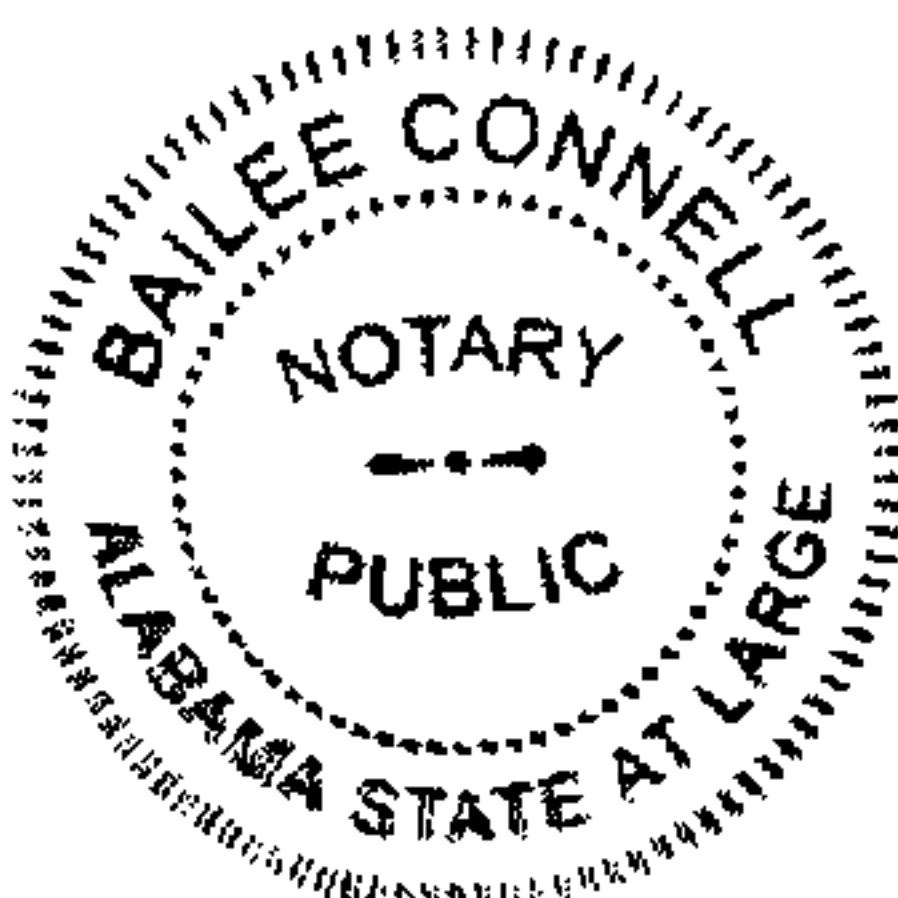
