

WARRANTY DEED WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS: That in consideration of **Four Hundred Five Thousand and No/100 Dollars (\$405,000.00)** and other good and valuable consideration, to the undersigned grantor, in hand paid by the grantees herein, the receipt where is acknowledged I, **Clementine Richardson, an unmarried person** (herein referred to as grantor), grant, bargain, sell and convey unto **Roderick Daniel and Terri C. Daniel** (herein referred to as grantee) for and during their joint lives, and upon death of any of them, then to the survivor(s) of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby** County, Alabama, to wit:

Lot 1130, according to the Survey of Lauchlin at Ballantrae, Phase 2, as recorded in Map Book 38, Page 114, in the Office of the Judge of Probate of Shelby County, Alabama.

This conveyance and the warranties hereinafter contained are made subject to any and all covenants, restrictions, reservations, rights of way of record and easements heretofore imposed upon the subject property.

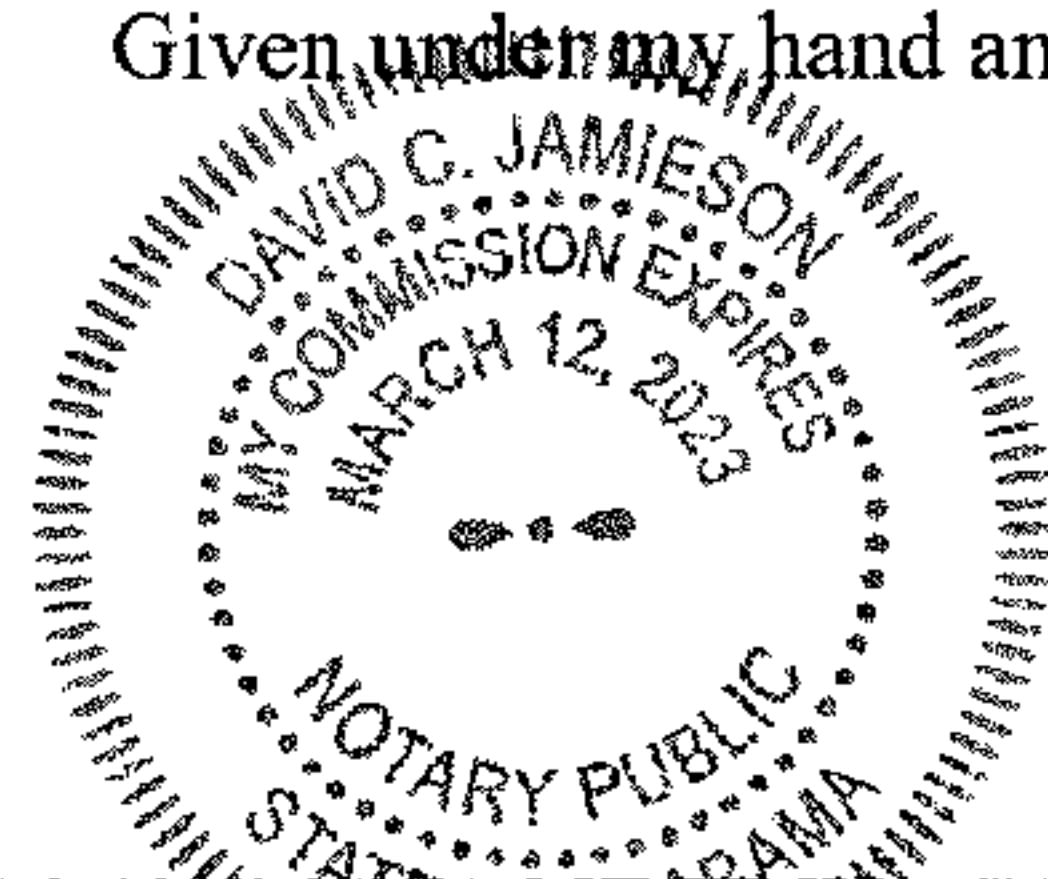
