WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

On this October 29, 2021, That for and in consideration of **THREE HUNDRED SIXTY SEVEN THOUSAND AND NO/100 (\$367,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **RIKKI S. LEE, an unmarried person**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **WENDI HEADLEY and JASON HEADLEY**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 7, according to Chelsea South Estates, Sector One, as recorded in Map Book 8, Page 14, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2022 and subsequent years not yet due and payable.-
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 8, Page 14.
7. Building setback line of 50 feet reserved from Shelby County Highway No. 49 as shown by plat.
8. Public utility easements as shown by recorded plat, including 20 foot easement on North and East sides and 10 foot on South side.
9. Restrictions, covenants, conditions as set out in instrument recorded in Map Book 8, Page 14.
10. Easement of Alabama Power Company as shown by instrument recorded in Real 42, Page 664.

Rikki S. Lee is the surviving grantee of that certain warranty deed with right of survivorship filed of record on September 18, 1986 in Book 091, Page 215; the other grantee, James W. Lee, having died on or about August 23, 2011. Rikki S. Lee and James W. Lee were married at the time of his death and no there was no pending divorce proceeding.

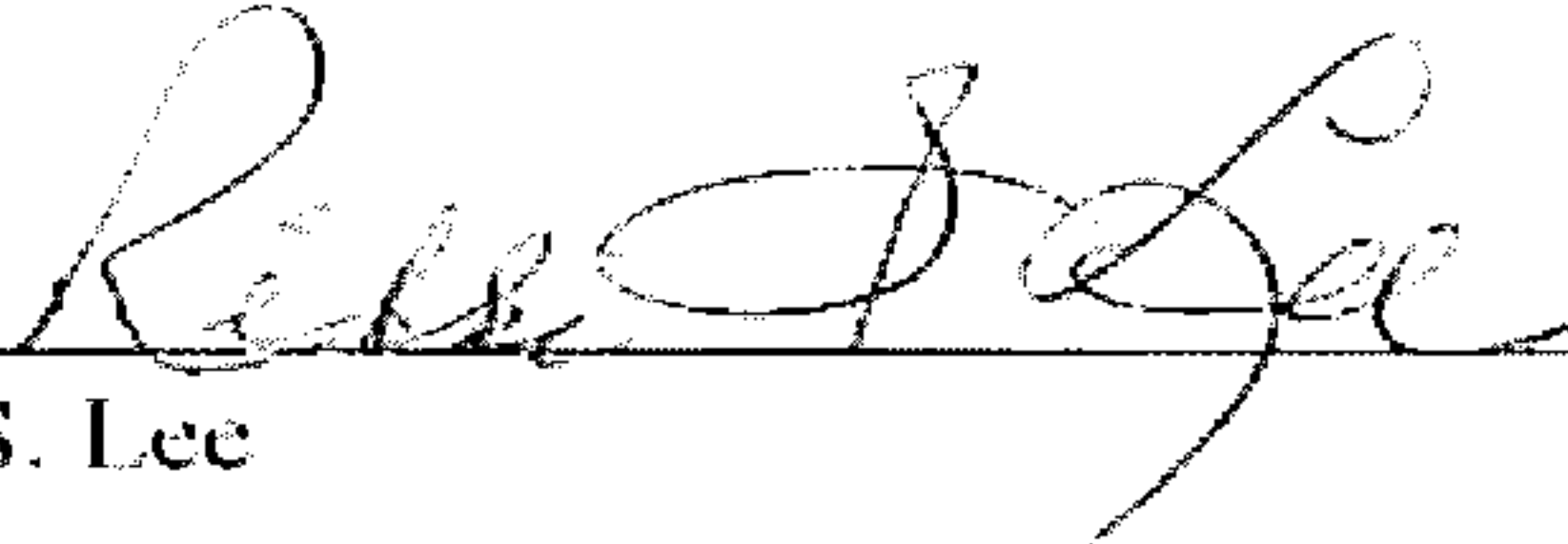
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

AND SAID GRANTOR, for said GRANTOR'S, GRANTOR'S heirs, successors, executors and administrators, covenants with GRANTEEES, and with GRANTEEES' heirs and assigns, that GRANTOR is lawfully seized in fee simple of the said Real Estate; that said Real Estate is free and clear from all liens and encumbrances, except as hereinabove set forth, and except for taxes due for the current and subsequent years, and except for any restrictions pertaining to the Real Estate of record in the Probate Office of **SHELBY COUNTY**; and that GRANTOR will, and GRANTOR'S heirs, executors and administrators shall, warrant and defend the same to said GRANTEEES, and GRANTEEES' heirs and assigns, forever against the lawful claims of all persons.

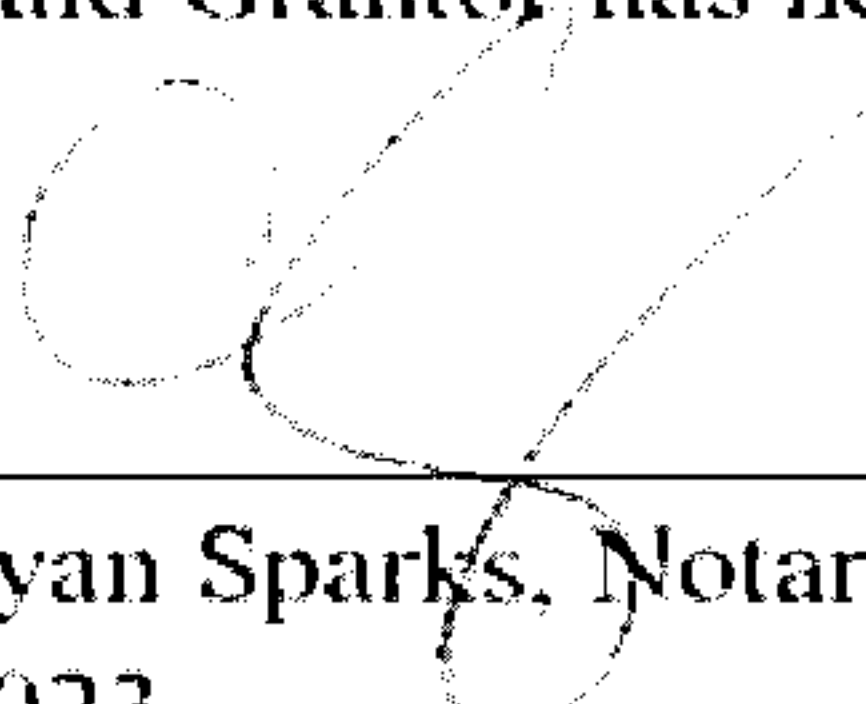

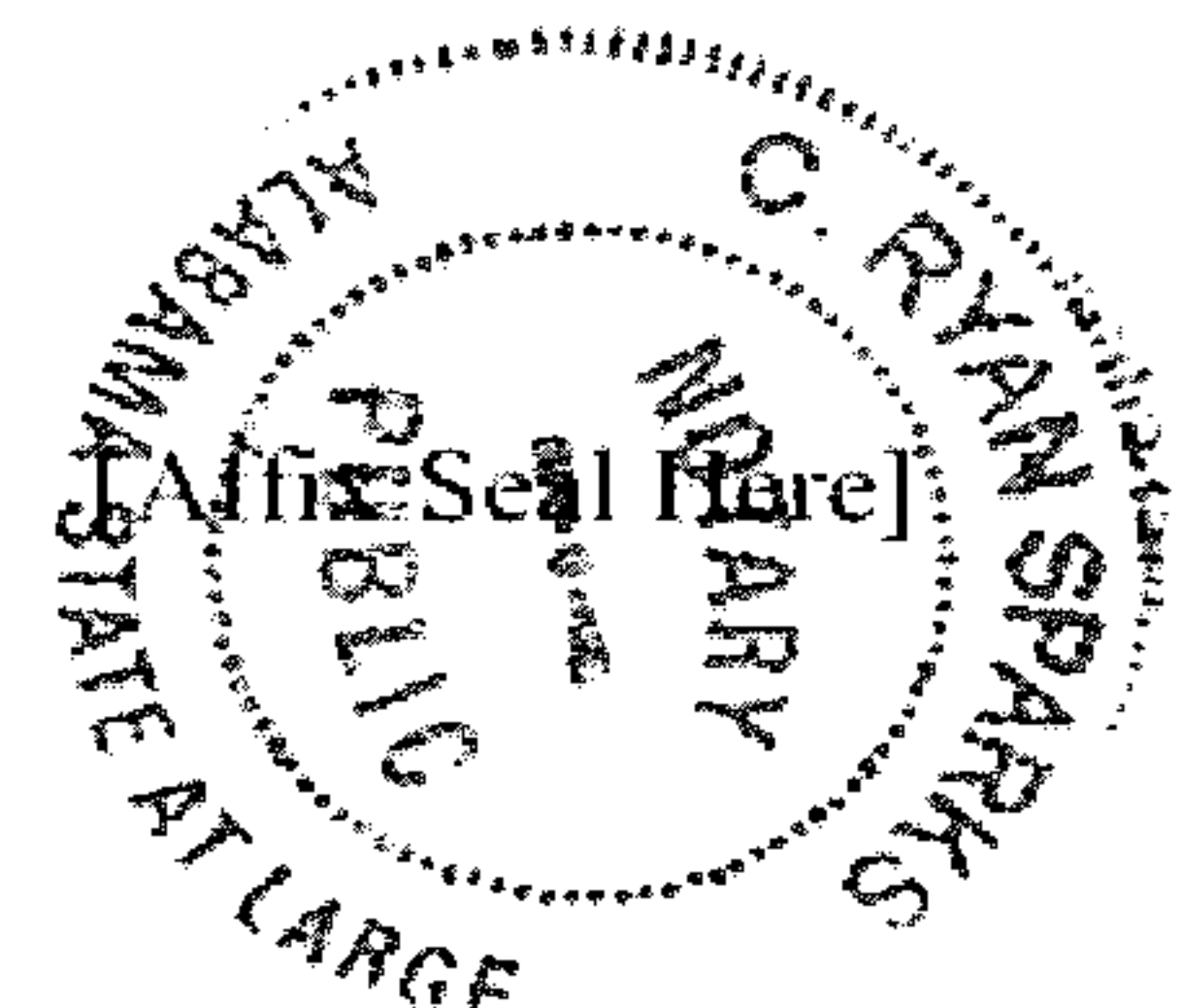
