(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

**Carrie McFerran and John Burgess**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

**\$475,000.00** of the proceeds come from a mortgage recorded simultaneously herewith.


- Subject to:

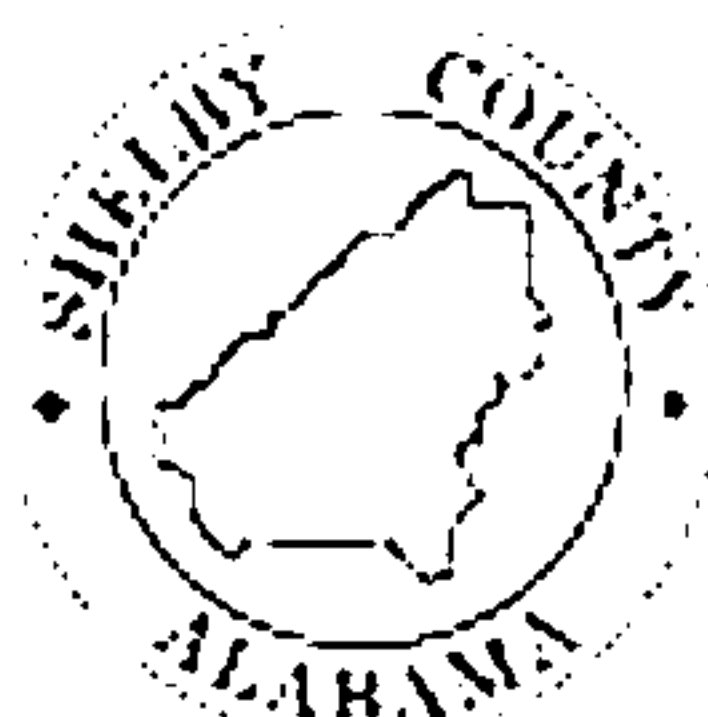
