Naugher, an unmarried person** (herein referred to as grantor), grant, bargain, sell and convey unto **Timothy Cottingham Jr and Mashayla B Cottingham** (herein referred to as grantee) for and during their joint lives, and upon death of any of them, then to the survivor(s) of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:

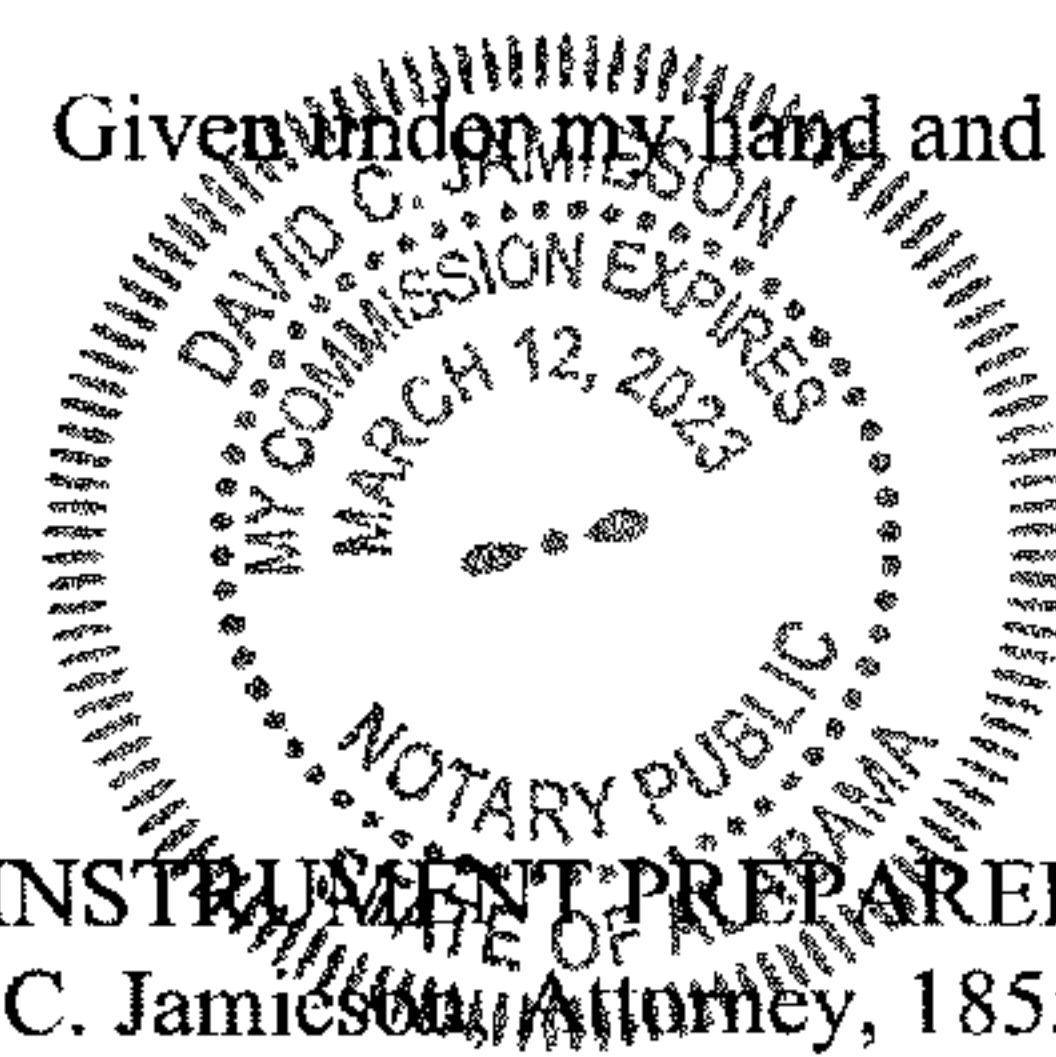


