



Commence at the NE corner of the NE ¼ of Section 32, Township 19 South, Range 1 East, Shelby County, Alabama and run South along the East line of said ¼-section 626.27 feet to a point of intersection with the centerline of a pipeline easement; thence right 68 degrees 00 minutes and run Southwesterly along said centerline 1172.10 feet to point of beginning; thence continue along last described course 173.17 feet; thence right 107 degrees 40 minutes 17 seconds and run northerly 635.56 feet; thence right 90 degrees 00 minutes and run easterly 365.00 feet; thence right 90 degrees 00 minutes and run Southerly 318 feet; thence right 90 degrees 00 minutes and run southerly 263.71 feet to point of beginning.


