Pursuant to the provisions of Section 10A-5-2.03 of the Code of Alabama, as amended, DeShazo Crane Company, LLC, an Alabama limited liability company (the "Company") adopts the following Amendment to its Articles of Organization:

FIRST: The name of the Company is DeShazo Crane Company, LLC.

SECOND: The Company is an Alabama limited liability company.





1. Names and States of Organization. The name and state of organization and public office where the formation documents for of each of the constituent entities are (a) DeShazo Service Company, LLC, which is organized under the laws of the State of Alabama, with its formation documents filed in the Judge of Probate's Office for Shelby County, Alabama and (b) DeShazo Crane Company, L.L.C., which is incorporated under the laws of the State of Alabama, with its formation documents filed in the Judge of Probate's Office for Jefferson County, Alabama.
