

STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of Four Hundred Forty Four Thousand Seven Hundred Twenty and No/100 Dollars (\$444,720.00) to the undersigned grantor, EMBASSY HOMES, LLC, an Alabama limited liability company, (herein referred to as "Grantor"), in hand paid by Grantee named herein, the receipt of which is hereby acknowledged, the said EMBASSY HOMES, LLC, an Alabama limited liability company, does by these presents, grant, bargain, sell and convey unto Tabitha P. Meadows Hough and Altonio D. Hough (hereinafter referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate (the "property"), situated in Shelby County, Alabama, to-wit:
