WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **One Million Four Hundred Seventy Five Thousand and 00/100 Dollars (\$1,475,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Sean P. Casey, and his wife, Laura K. Casey

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Edward B. Parker, II and Tina K. Parker

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 14, according to the Map and Survey of The Crest at Greystone Second Addition, as recorded in Map Book 19, Page 53, in the Office of the Judge of Probate of Shelby County, Alabama.

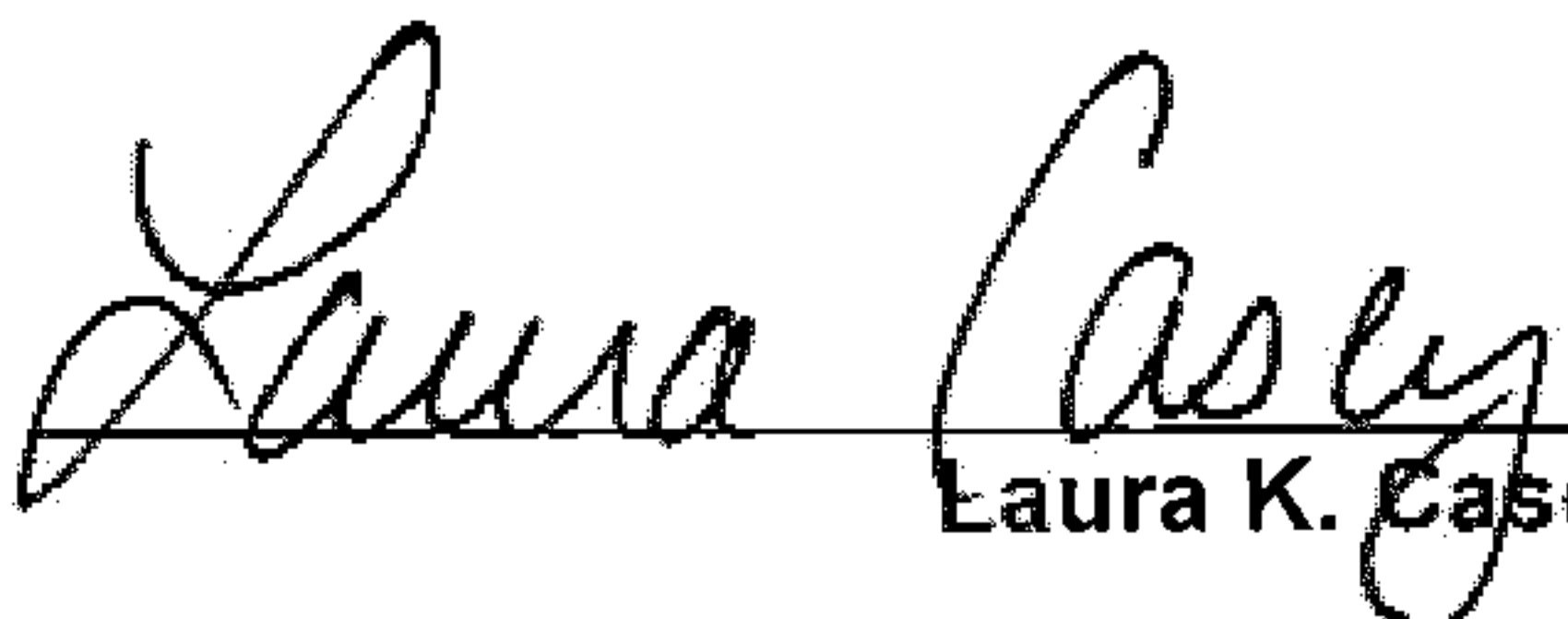
\$1,180,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

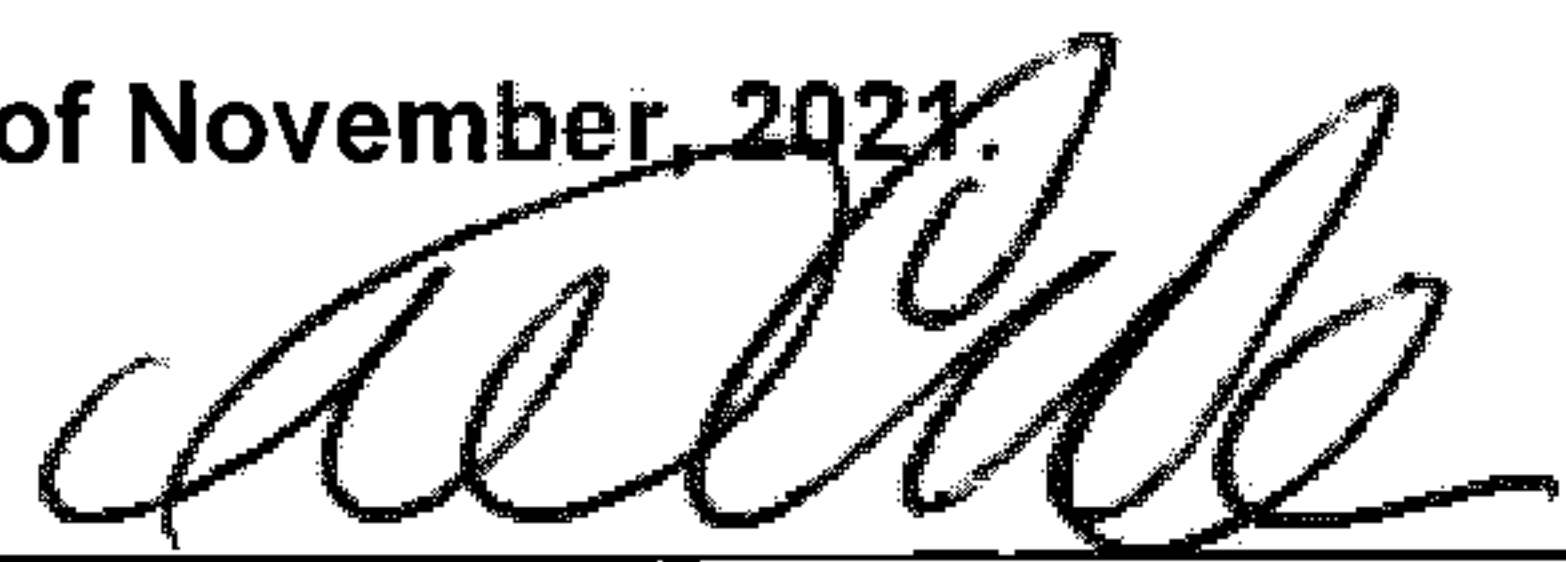

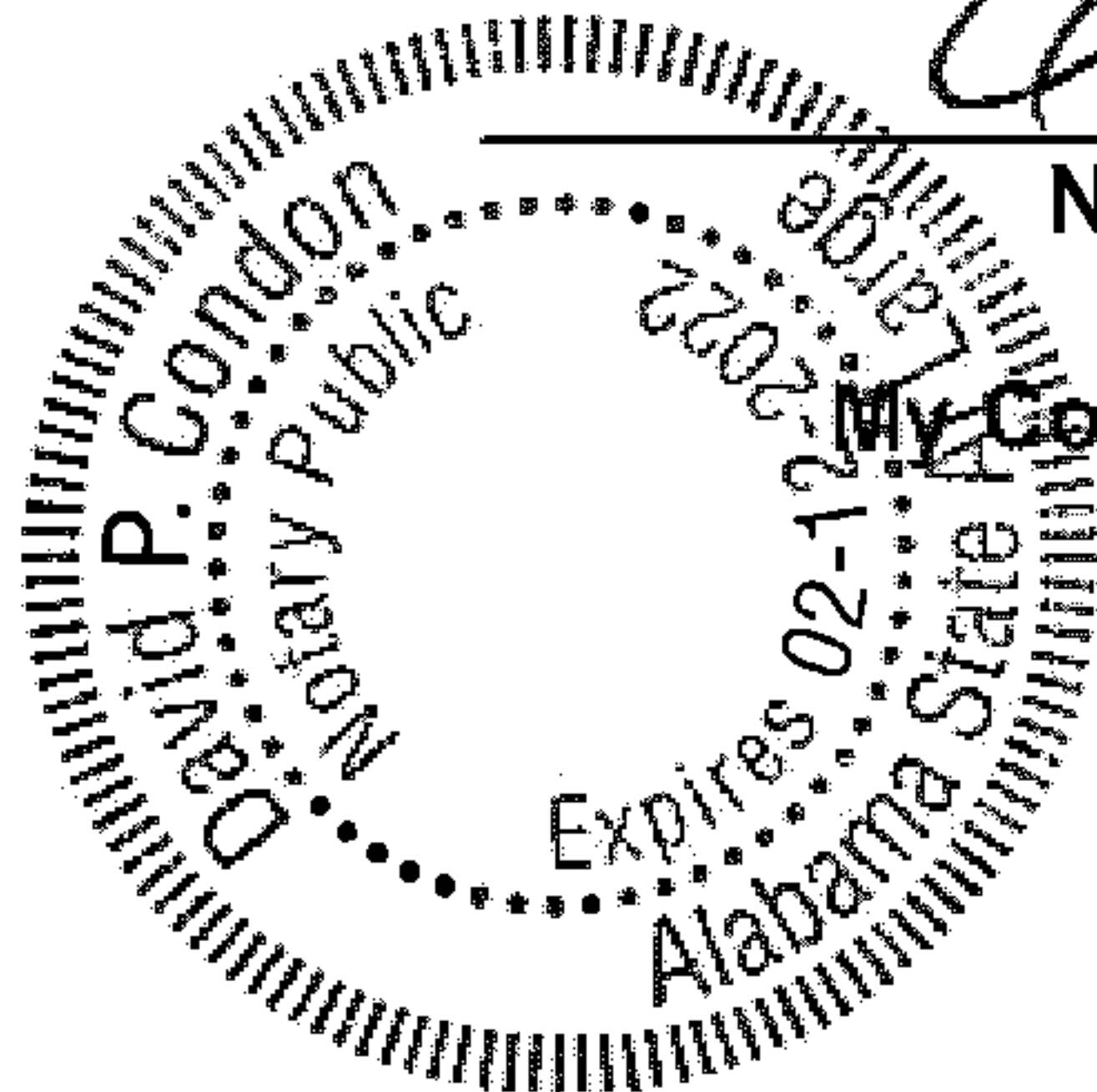

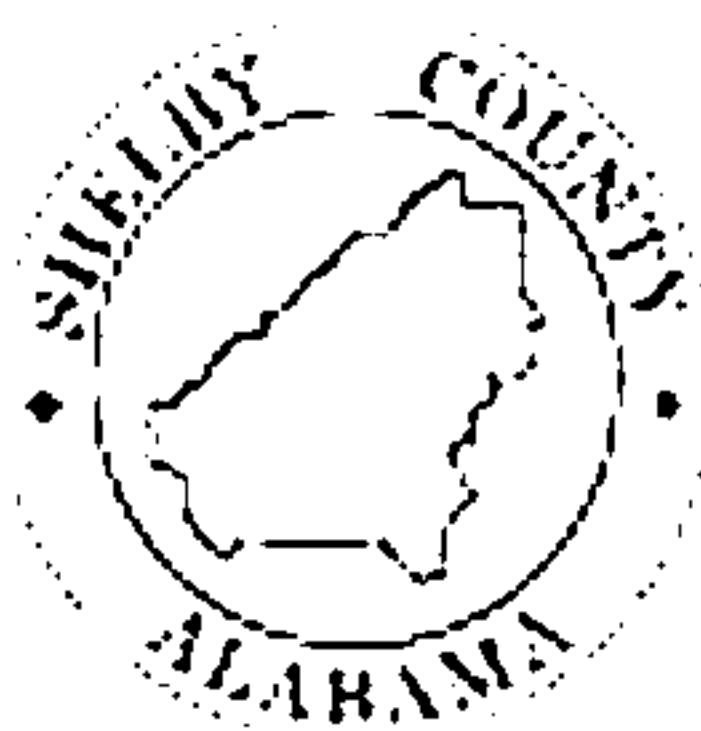
