**Property may be subject to all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded.**


**\$185,576.00** of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.
