KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of FOUR HUNDRED TWENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$425,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantor, **KELLY A. TATE, an unmarried woman** (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **CAROL A. KEY and RICHARD D. KEY** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 26A, according to the Survey of the Residential Subdivision: Beaumont-Phase 5, Resurvey of Lots 1-31, as recorded in Map Book 40, Page 5, in the Probate office of Shelby County, Alabama.

Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, mineral/mining rights, and declarations of record, if any.

\$382,500.00 of the above-recited consideration is being paid with a purchase money mortgage being recorded simultaneously herewith.

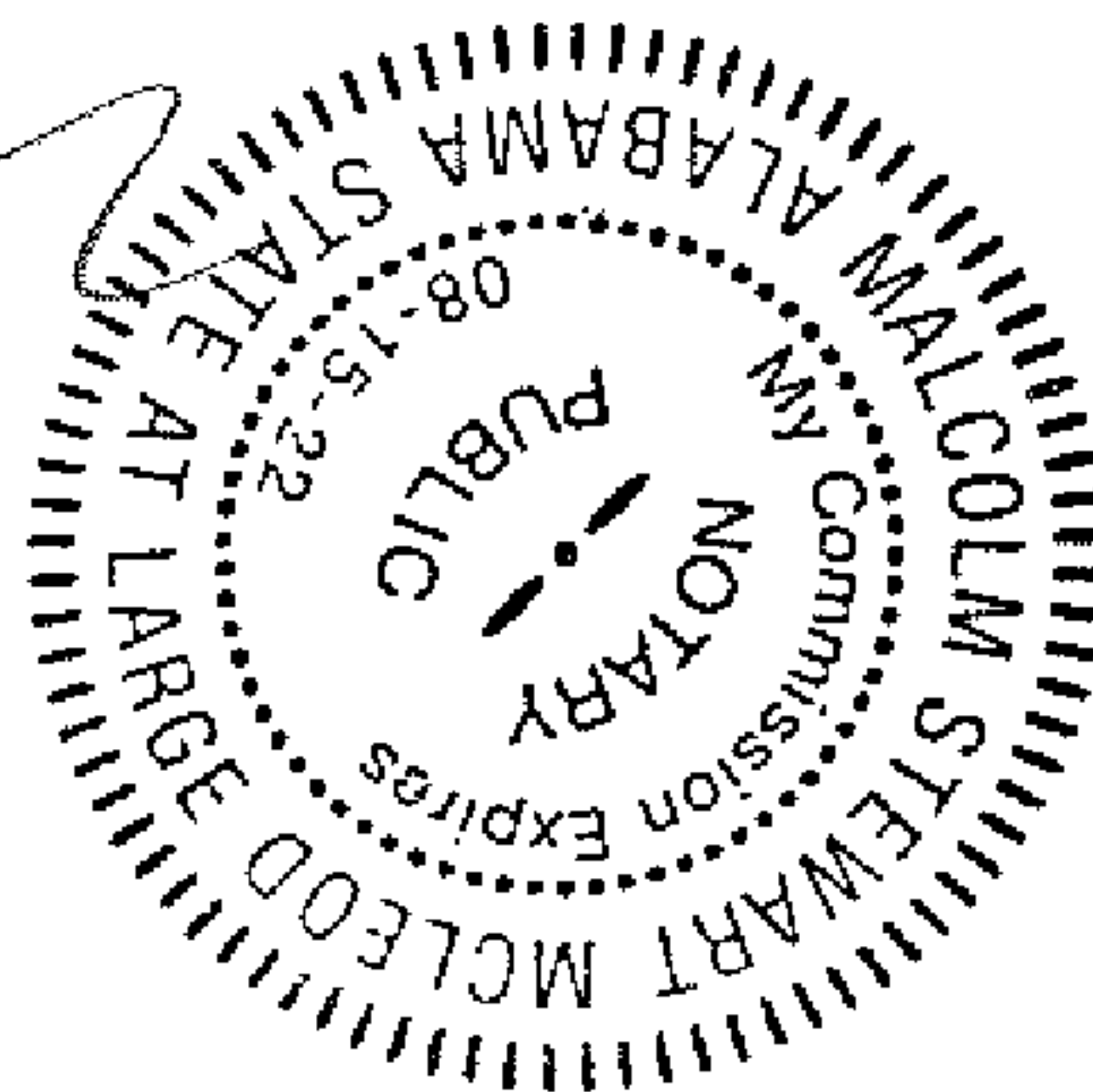
