2. Easements, restrictions, rights of way, and permits of record.


Grantor herein reserves a Life Estate in and to the above described property.



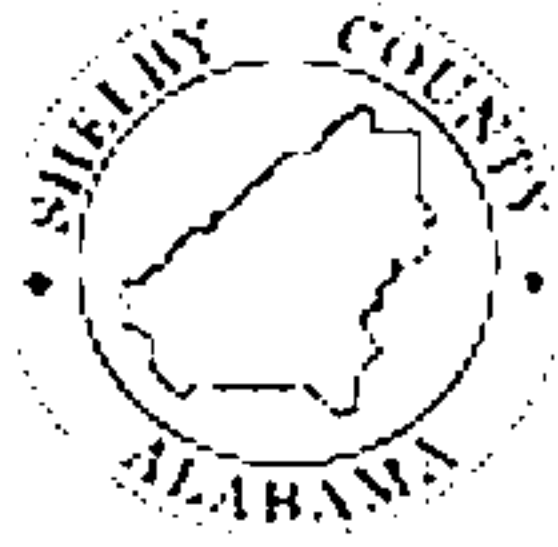
