**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS,**

On this November 1<sup>st</sup>, 2021, That for and in consideration of **FIVE HUNDRED THIRTY FIVE THOUSAND AND NO/100 (\$535,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **WILLIAM A. STRAZEWSKI, an unmarried man, and BETSY L. STRAZEWSKI, an unmarried woman**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **JONATHAN AVILA and YVONNE M. AVILA and SAMUEL AVILA, and STEPHEN AVILA, and JUNE AVILA**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 43, according to the Survey of High Chaparral, Sector B, as recorded in Map Book 16, Page 69, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2022 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.





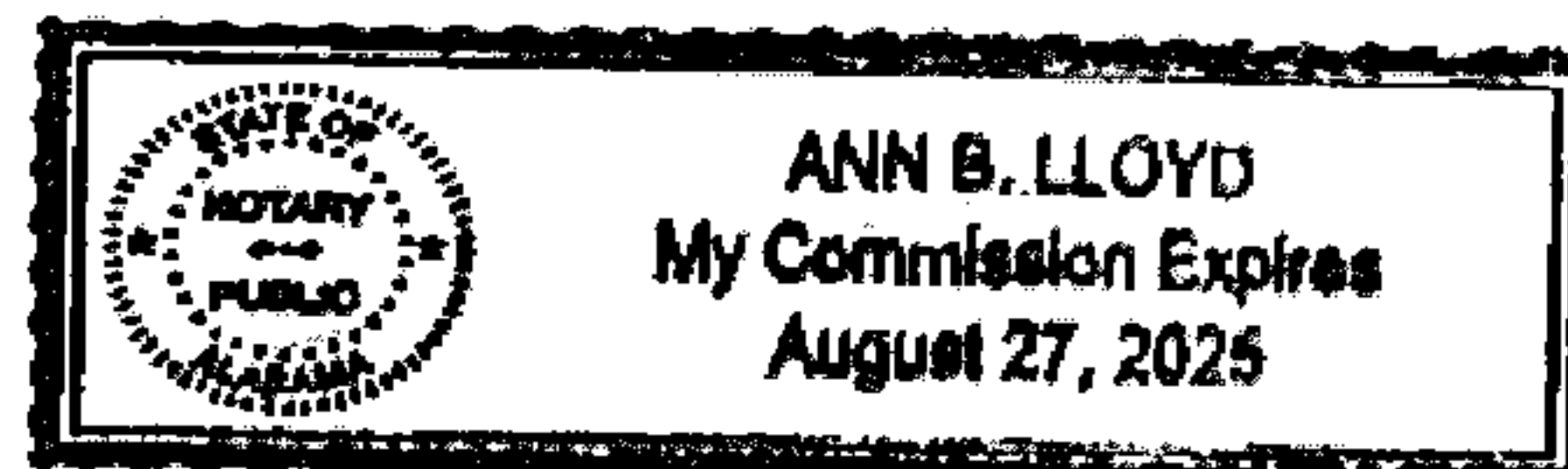
