**KNOW ALL MEN BY THESE PRESENTS:** That for and in consideration of the sum of Ten and no/100 Dollars (\$10.00) cash in hand paid by the CITY OF ALABASTER, ALABAMA, the receipt whereof is hereby acknowledged, we, the undersigned, do hereby quitclaim, grant, convey and dedicate unto the said City, its successors and assigns, a right-of-way and easement for public purposes, including a sanitary sewer pumping facility other public utilities and devices both below and above ground. Said right-of-way being located in Shelby County, Alabama and described as follows, to-wit:

**PARCEL FOR PUMP STATION**

A parcel of land located in the Southeast Quarter of the Southeast Quarter of Section 22, Township 21 South, Range 3 West, and in the Northeast Quarter of the Northeast Quarter of Section 27, Township 21 South, Range 3 West, Shelby County, Alabama, being more particularly described by the following metes and bounds description being based on plat bearings derived from the Map or Plat of WYNLAKE SECTOR 5 as recorded in Map Book 40, Page 125 in the Office of the Judge of Probate of Shelby County, Alabama.

BEGIN at a 2" open pipe occupying the Northeast corner of Section 27, Township 21 South, Range 3 West Shelby County Alabama; thence South 01°52'53" West along the east line of said Section 27 for a distance of 66.56 feet to a capped rebar found stamped "LD WEYGAND 10373"; thence North 56°05'38" West leaving the east line of said Section 27 for a distance of 96.79 feet to a point; thence North 74°03'55" West for a distance of 100.00 feet to a point on the easterly right of way of Wynlake Drive as shown on the Map or Plat of WYNLAKE PHASE 4B as recorded in Map Book 22, Page 63 in the aforesaid Probate Office; thence North 15°56'24" East for a distance of 22.00 feet to a point; thence South 74°03'55" East for a distance of 104.69 feet to a point; thence North 23°12'21" East for a distance of 57.06 feet to a point; thence South 89°29'09" East for a distance of 50.01 feet to a point on the east line of said Section 22; thence South 00°30'51" West along said east line of Section 22 for a distance of 59.34 feet to the POINT OF BEGINNING. Said parcel containing 9,189 square feet or 0.211 acres more or less.

For the consideration aforesaid, the undersigned do quitclaim, grant, convey and dedicate unto said City the right and privilege of a perpetual use of said lands for such public purpose, together with all rights and privileges necessary or convenient for the full use and enjoyment thereof, including the right of ingress to and egress from said area and the right to cut and keep clear all trees, undergrowth and other obstructions on the lands of the undersigned adjacent to said area when deemed reasonably necessary for the avoidance of danger in and about said public use of said area, and the right to prohibit the construction or maintenance of any improvement or obstruction on, over, across or upon said area herein conveyed without the written permission from the City of Alabaster.

In consideration of the benefit to the property of the undersigned by reason of the construction of said improvement, the undersigned hereby release the City of Alabaster, Shelby County, the State of Alabama, and/or the United States of America, and/or any of their agents, from all damages present or prospective to the property of the undersigned arising or resulting from the construction, maintenance and repair of said improvement, and the undersigned do hereby admit and acknowledge that said improvement, if and when constructed, will be a benefit to the property of the undersigned.

The undersigned covenant with said the City of Alabaster that the undersigned are all the owners of said property and are each seized in fee-simple of said premises and have a good right to sell and convey the same and that the same are free from all encumbrances, and the undersigned will warrant and defend the title to the aforegranted grounds from and against the lawful claims of all persons whomsoever.
