Ann Ingram Hodgens and Ann Ingram Tyler are one and the same person.

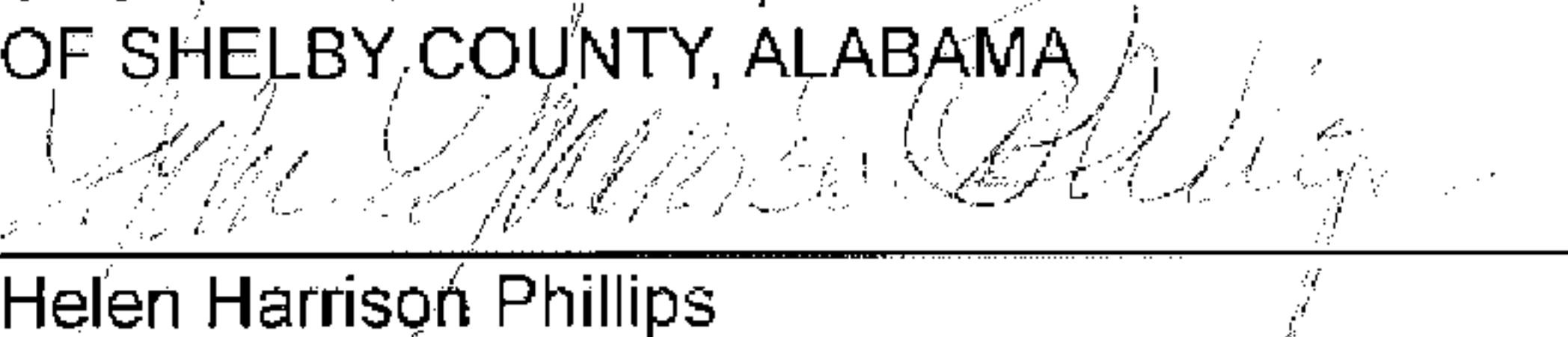

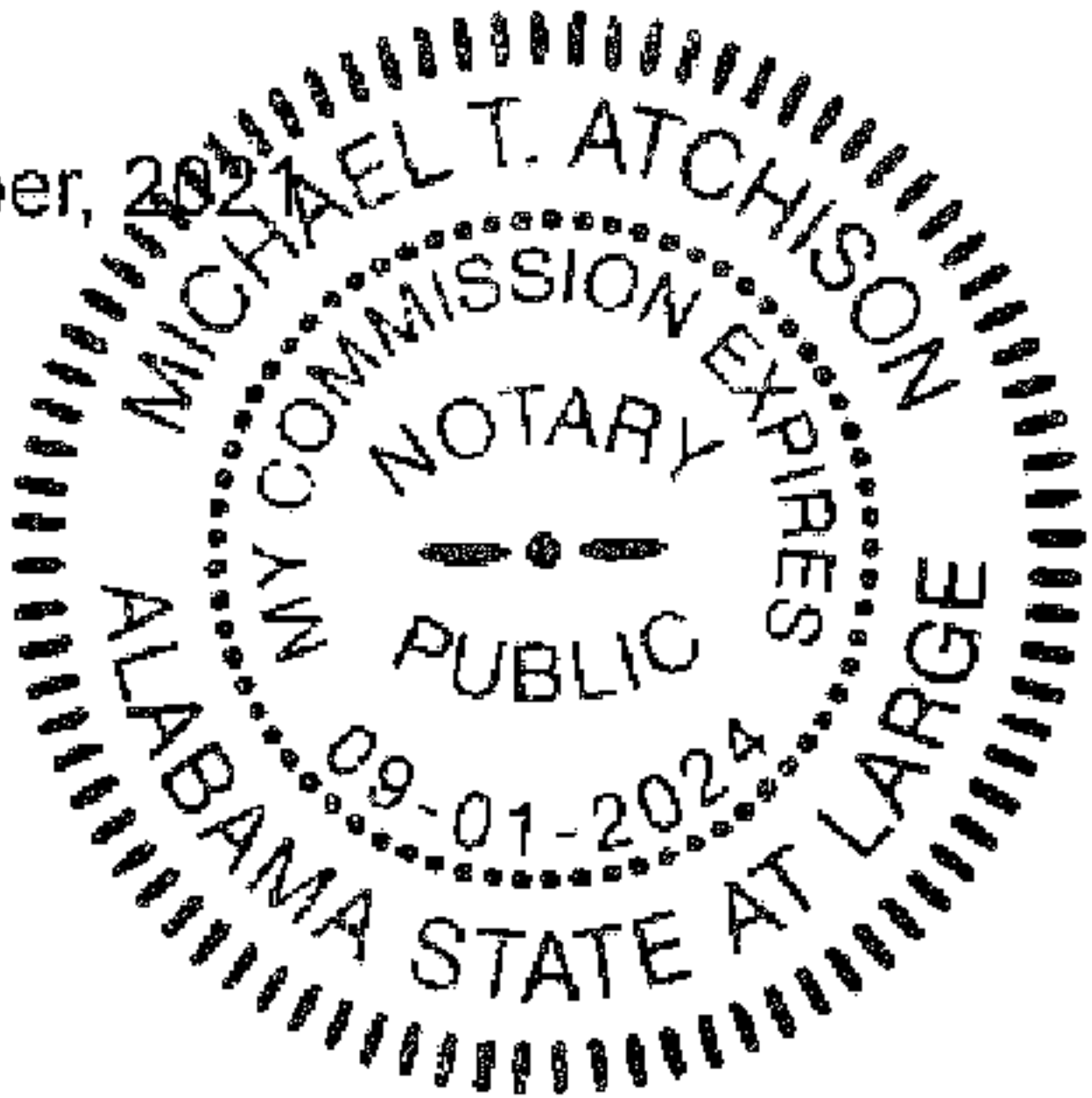
