**FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of February, 2015, Nathan Marc Caputo, Unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for USAA Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Book Page , said mortgage having subsequently been transferred and assigned to U.S. Bank National Association, by that instrument recorded as instrument number 20150311000075390 , in the aforesaid Probate Office ("Transferee"); and

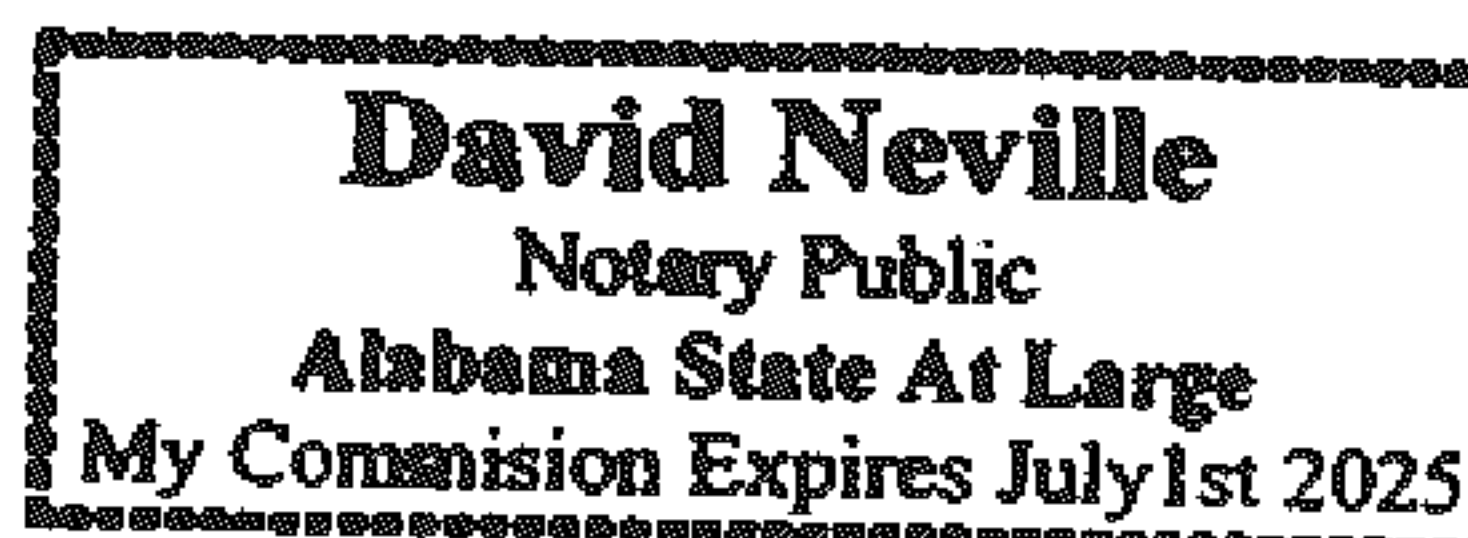
