## WARRANTY DEED

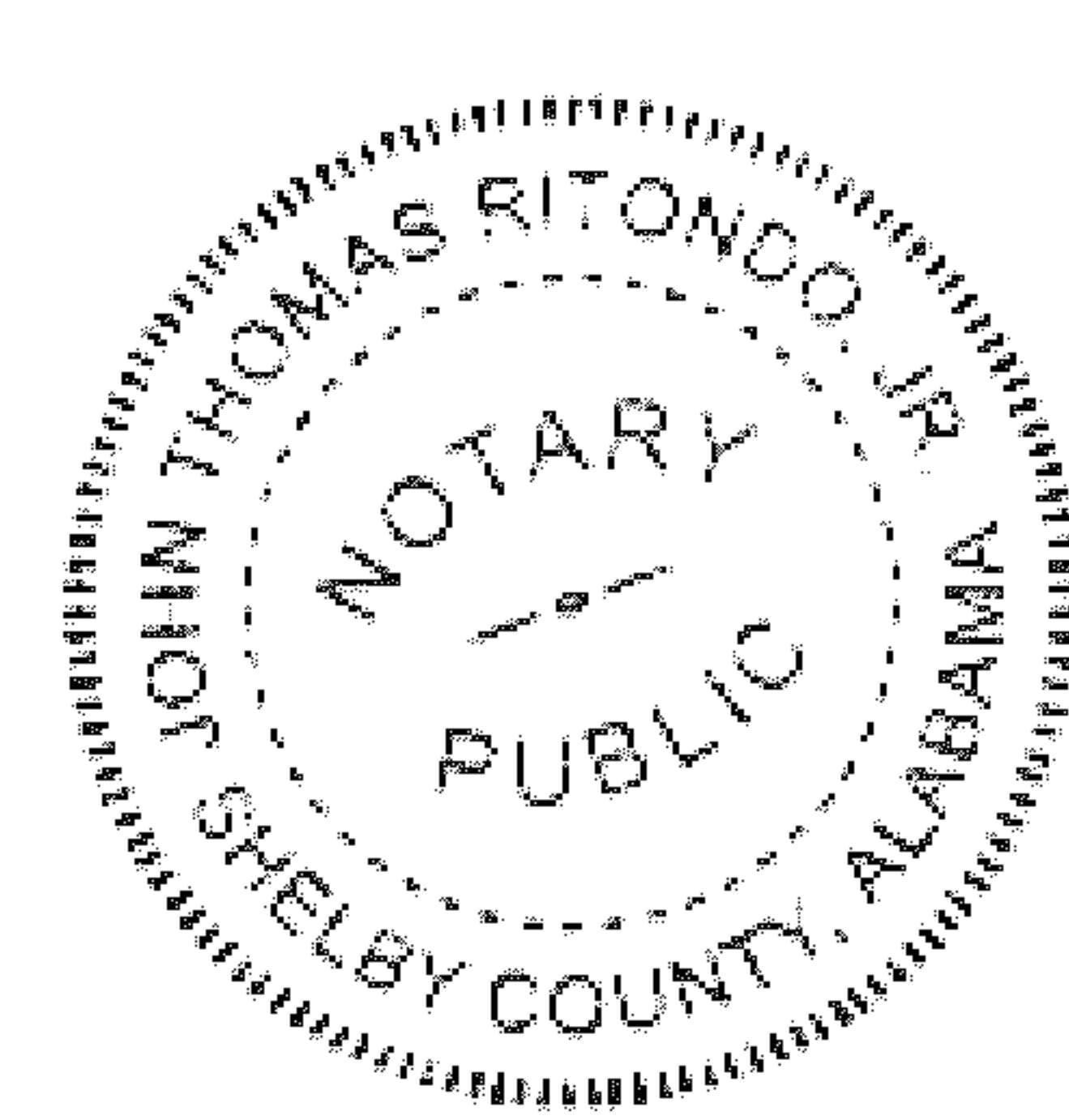
