KNOW ALL MEN BY THESE PRESENTS,

On this November 30, 2021, That for and in consideration of TWO HUNDRED EIGHTY THOUSAND AND NO/100 (\$280,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS TERESA PARKER, an unmarried person, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, RIKKI LEE, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:

Lot 86, according to the Amended Map of Final Record Plat of Narrows Peak Sector, as recorded in Map Book 31, Page 125 A & B, in the Probate Office of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Areas as more particularly described in the Narrows Residential Declaration of Covenants, Conditions and Restrictions recorded in Instrument #2000-9755, as amended by Instrument #2000-17136; Instrument #2000-36696 and Instrument #2001-38328 all recorded in the Probate Office of Shelby County, Alabama (which, together with all amendments thereto, is hereinafter collectively referred to as the "Declaration").

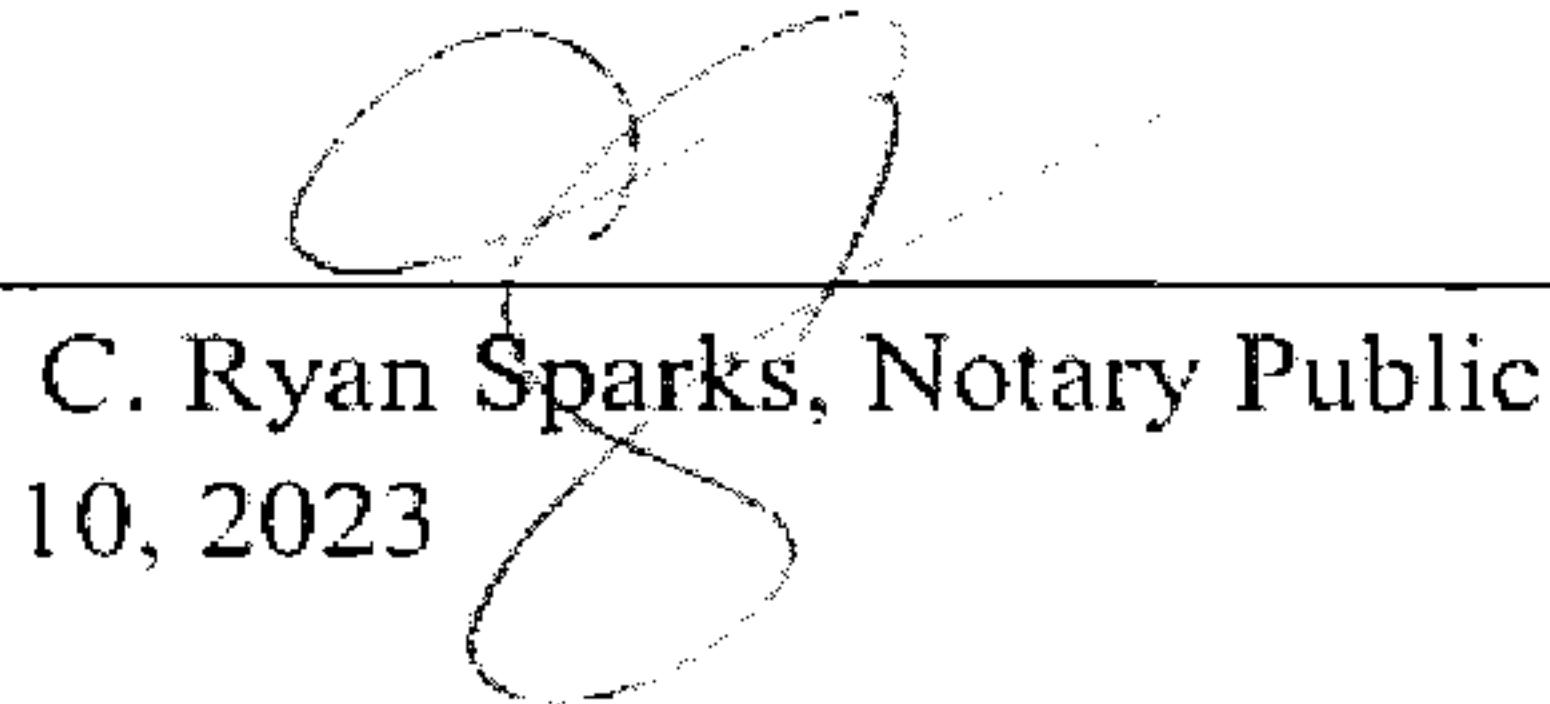
