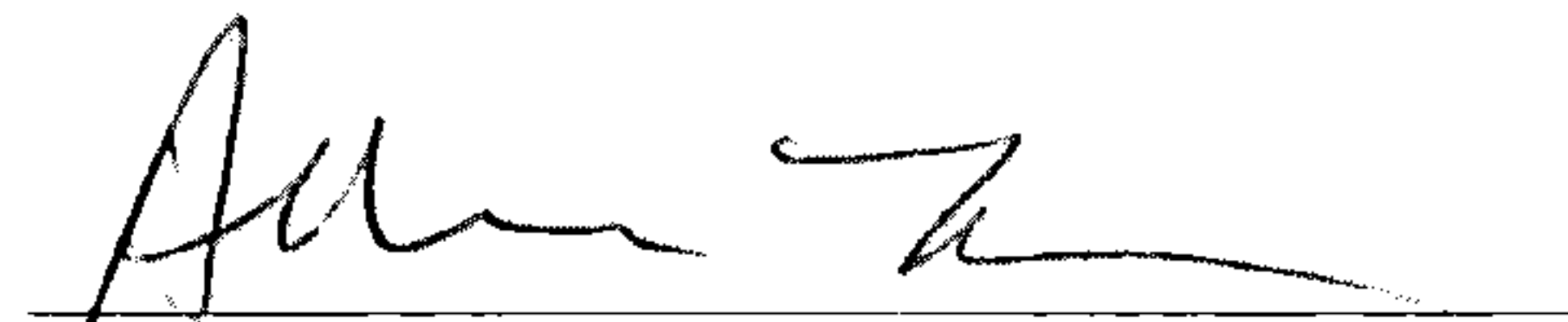
1. Taxes for the year 2021 and all subsequent years.

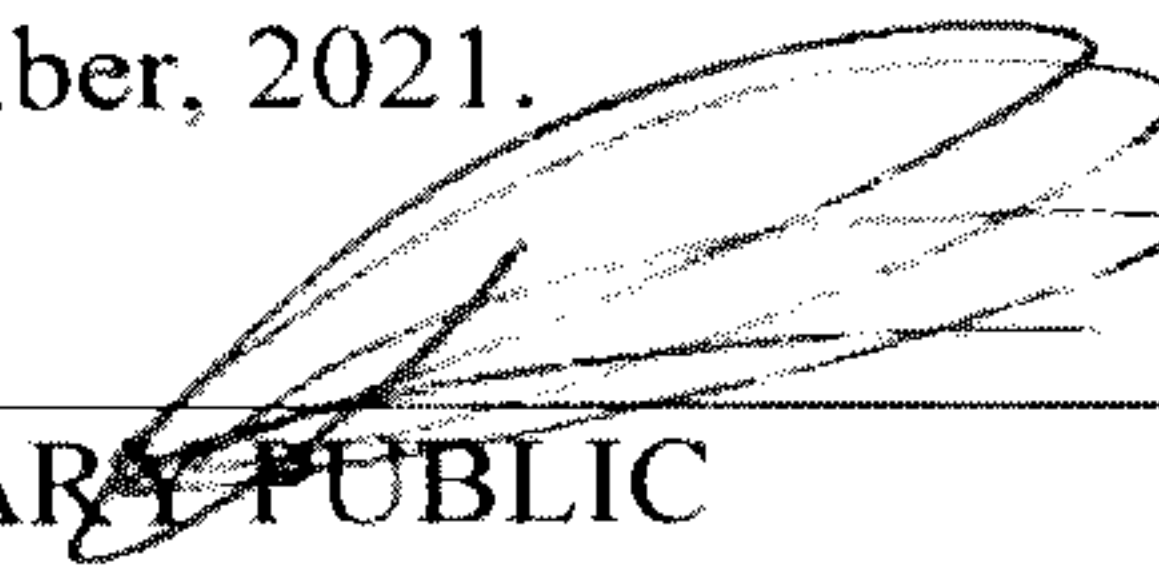
