WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Five Hundred Ninety Nine Thousand Nine Hundred and 00/100 Dollars (\$599,900.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Jefferson Gann and Tiffany Gann

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 113, according to the Survey of the Amended Map of The Cove of Greystone, Phase I, as recorded in Map Book 26, Page 39 A & B, in the Office of the Judge of Probate of Shelby County, Alabama.

\$479,920.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2022 ad valorem taxes not yet due and payable;

 (3) all easements, rights-of-way, restrictions, covenants and

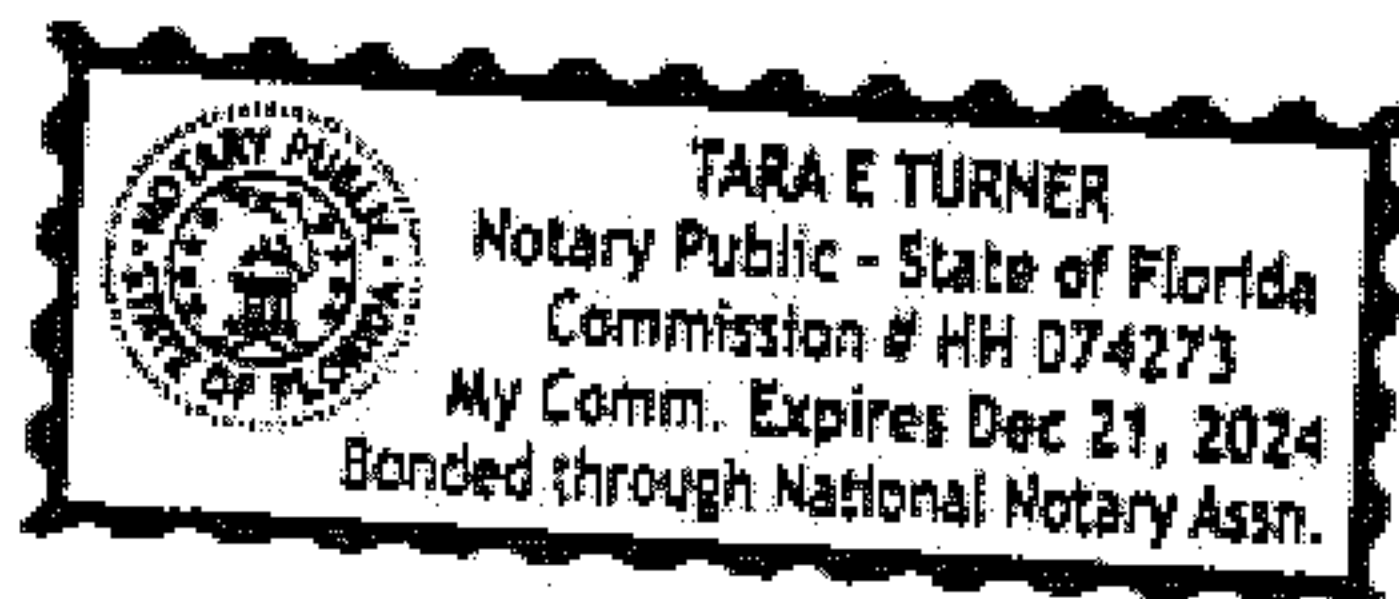
