FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, August 25, 2017, Curtis Jerome Putman Sr an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for Renasant Bank, which said mortgage was recorded in Instrument No. 20170829000314820 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to M&T Bank by instrument recorded in Instrument Number 20210923000464430 in the aforesaid Probate Office Transferee and

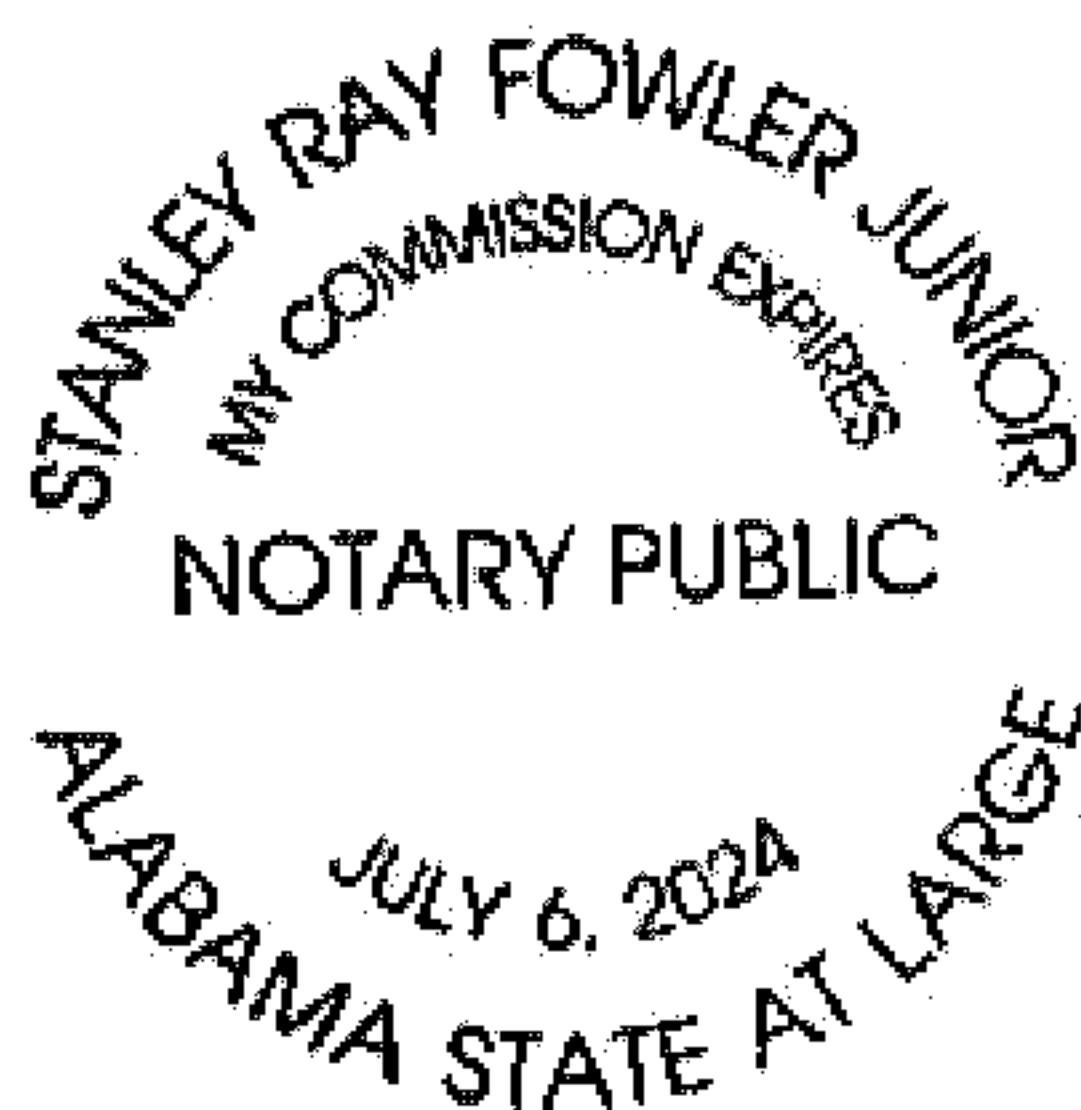

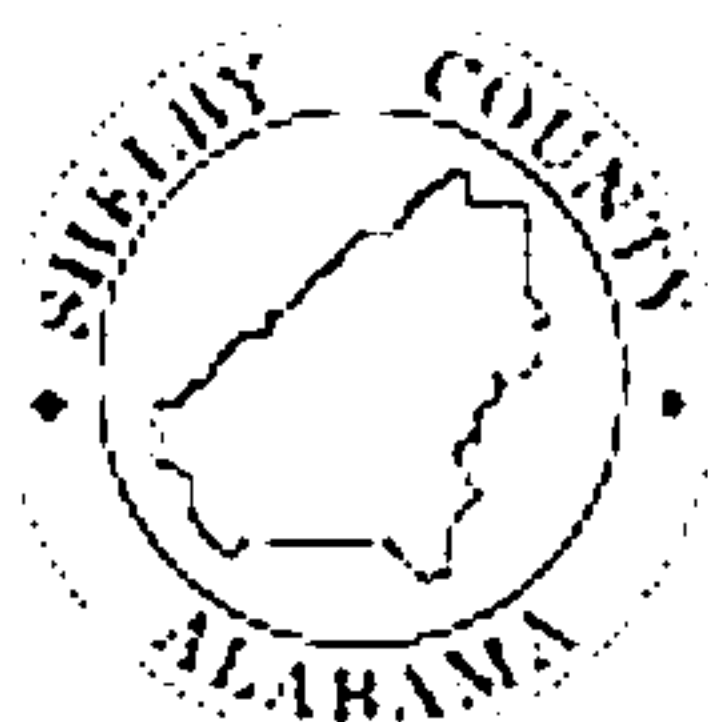
