Affiant states that his/her relationship to the Decedent was that of Friend of the family (state relationship to decedent).

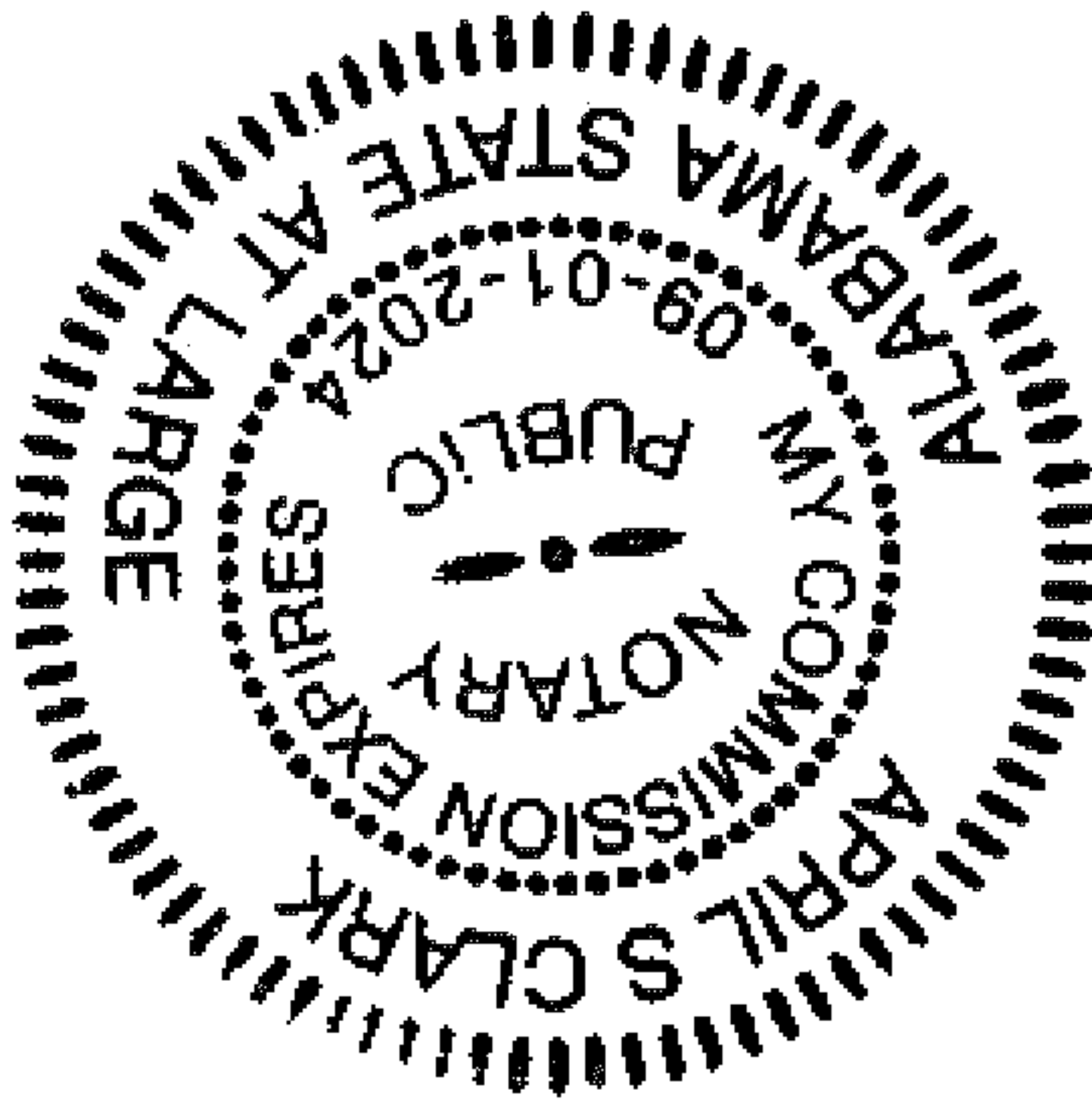
