The affiant, being duly sworn, states as follows:


1. That the affiant has personal knowledge of the facts set forth in this affidavit.

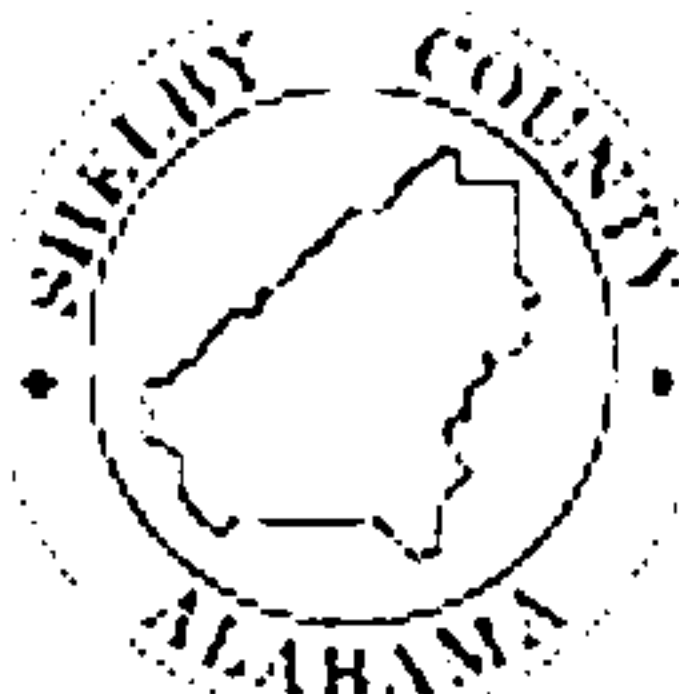
