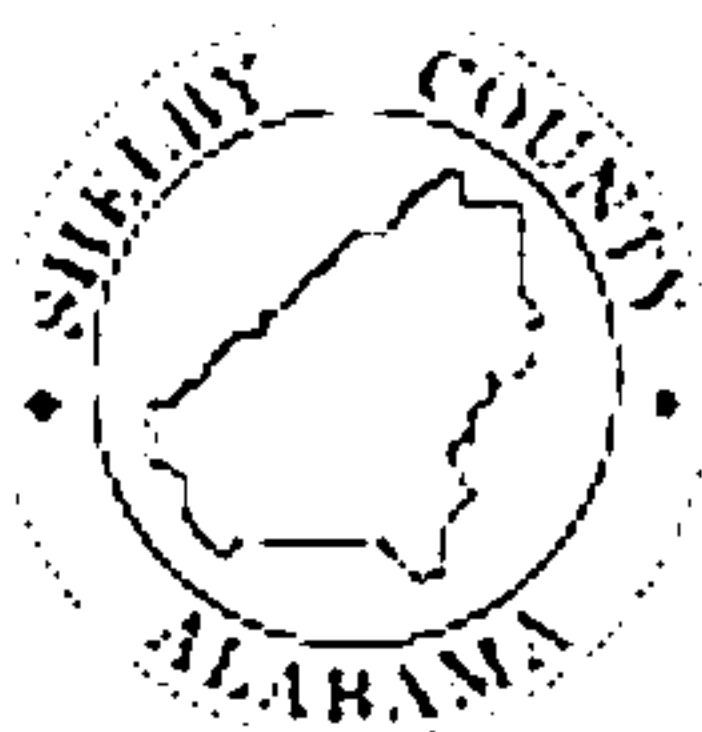
EXHIBIT A
