ORDER

THIS CAUSE came before the Court on the Memorandum Agreement submitted by the parties in settlement of the above cases. This Court having considered the same, it is

ORDERED, ADJUDGED, and DECREED:

1. That Section 7.2, paragraph 1, of the Final Judgment of Divorce entered September 9, 2011, is hereby modified to read as follows:

Section 7.2. 1. The Defendant shall pay to the Plaintiff the sum of Seven Hundred Eighty-two & No/100 Dollars (\$782.00) per month for the support and maintenance of the minor children of the parties beginning January 1, 2016, until such time as the minor children attain the age of nineteen (19) years, marry or otherwise become self-supporting. Defendant agrees to pay half of all extracurricular activities of the children, due and payable within seven (7) days of any request for same. Parties are to discuss extracurricular activities and reach an agreement as to participation if Defendant is required to pay for such activity.

2. That reference is hereby made in this Order to a separate order entitled, Income Withholding for Support, and said Order shall be entered, and **SERVED** immediately upon the Defendant's employer.

3. That the Defendant shall continue to exercise the visitation set forth in paragraph 7.4 of the Final Judgment of Divorce.

4. That Defendant is in civil contempt of court for his willful refusal to comply with this Court's Final Judgment of Divorce, and is in arrears in the payment of child support in the amount of **NINE THOUSAND SEVEN HUNDRED FORTY-TWO & No/100 DOLLARS**

(\$9,742.00) plus interest through September 30, 2016 of ONE THOUSAND THREE HUNDRED SIXTEEN & 80/100 DOLLARS (\$1,316.80). Judgment will be entered against the Defendant and in favor of the Plaintiff for **ELEVEN THOUSAND FIFTY-EIGHT & 80/100 DOLLARS (\$11,058.80).**

5. That Defendant shall purge himself of civil contempt by paying to Plaintiff the sum of **TWO HUNDRED EIGHTEEN & NO/100 DOLLARS (\$218.00)** per month toward the total arrearage through an Income Withholding Order until the total arrearage plus interest is paid in full.

6. That Defendant shall pay Plaintiff an attorney's fee of **SIX THOUSAND & NO/100 DOLLARS (\$6,000.00)** with which to pay her attorney of record, at the rate of **ONE HUNDRED & NO/100 DOLLARS (\$100.00)** per month for **SIXTY (60) MONTHS**, beginning October 1, 2016. Said payment shall be made directly to plaintiff's attorney, Kelly R. Knight, at 505 North 20th Street, Suite 620, Birmingham, Alabama 35203. No interest shall accrue on the balance as long as the payments are timely. Otherwise, interest shall accrue at the statutory rate of 7.5% per annum.

7. That all provisions of the Final Judgment of Divorce entered September 9, 2011, not modified herein, shall remain unaltered, unchanged, and in full force and effect.

8. That all costs of court accrued herein shall be taxed as paid.
