Know All Men by These Presents: That in consideration of **Three Hundred Thousand and 00/100 Dollars (\$300,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, I, **LAURA H. BOYD, an unmarried woman** (herein referred to as Grantor), grant, bargain, sell and convey unto **MICHAEL JACKS and ANGELA G. JACKS** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

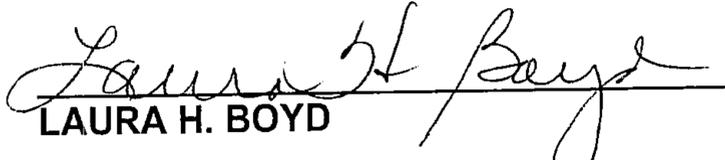
Subject to mineral and mining rights if not owned by Grantors. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

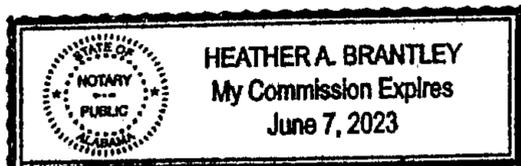

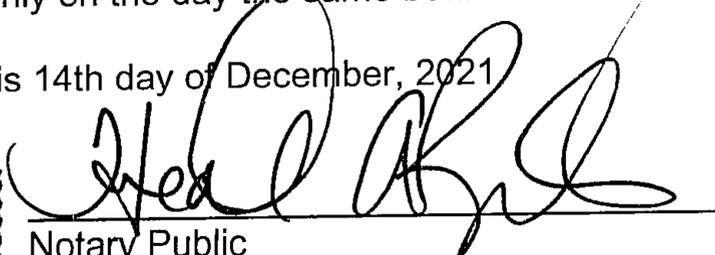
