WARRANTY DEED
JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

State of Alabama } Know All Men by These Presents:
County of Shelby

That in consideration of the sum of **Two Hundred Two Thousand Dollars and No Cents (\$202,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Rikki Pickett Lowery, a single woman** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Mary Lois Morris and Jennifer Morris**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama; to wit;

Lot 139, according to the Final Plat of Stonecreek, Phase 3, as recorded in Map Book 36, Page 37, in the Probate Office of Shelby County, Alabama.

Property may be subject to all 2022 taxes and subsequent years, covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded.

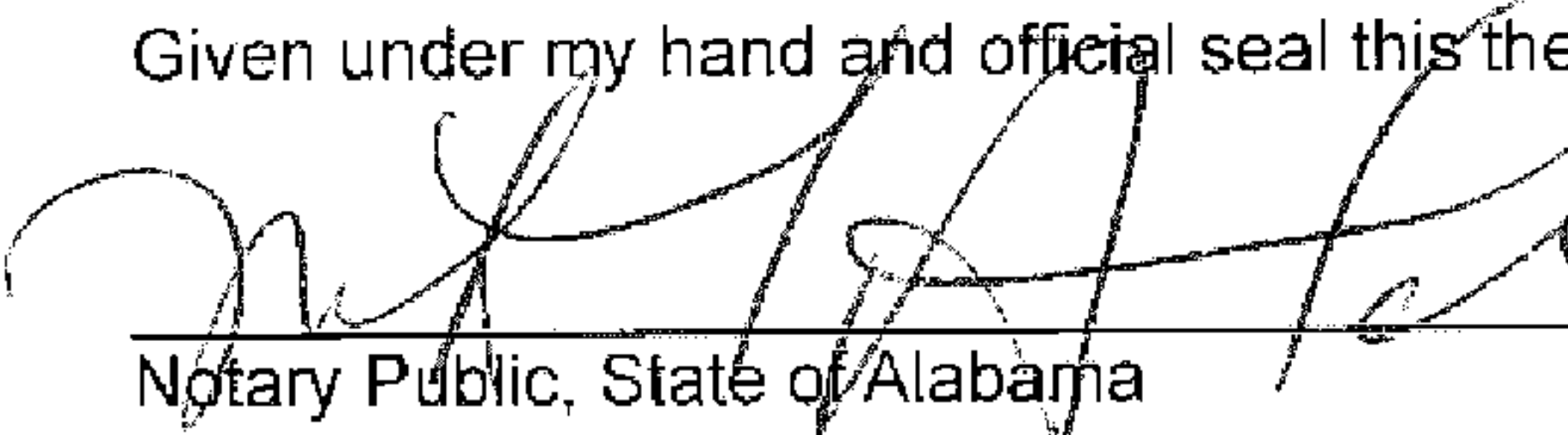

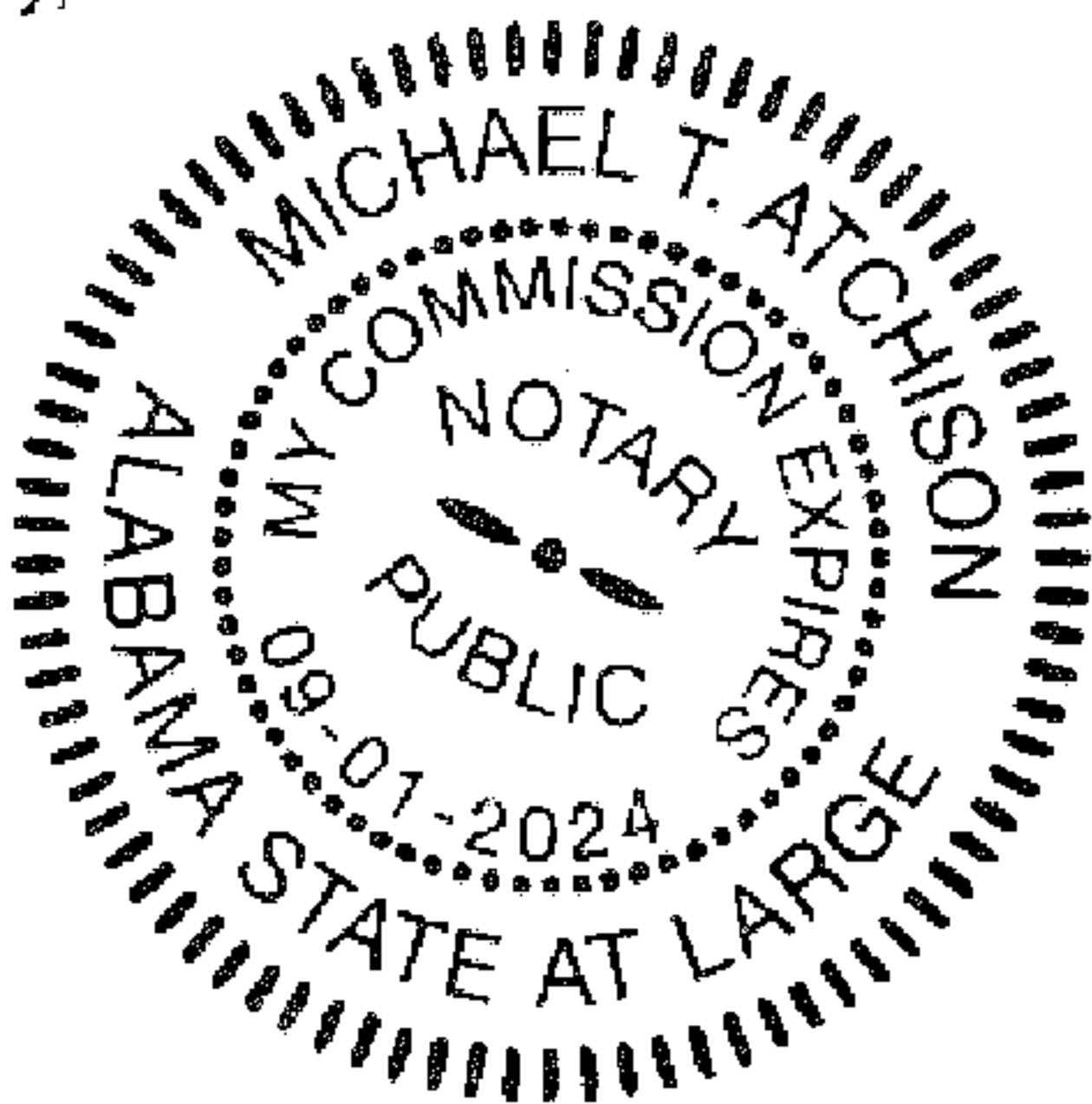
