However, any personal representative, a ternates or successors serving hereunder shall make out and keep an inventory and maintain records of all transactions relating hereto and shall exhibit the same to any party in interest at any reasonable time.

In all other respects, I ratify and confirm all of the provisions of my Last Will and Testament dated November 25, 2015.
