SURVIVORSHIP WARRANTY DEED

KNOW BY ALL MEN THESE PRESENTS:


Subject to ad valorem taxes for the current year, and subsequent years.

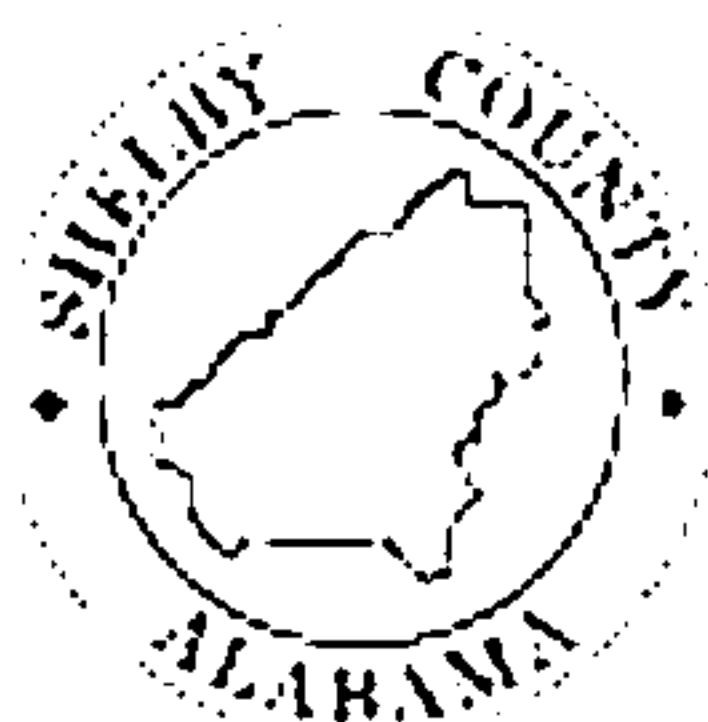

