DURABLE POWER OF ATTORNEY

ARTICLE I
STATEMENT OF INTENT TO CREATE
DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That I, MARY ANN DOYLE WADDELL, have made, constituted and appointed, and by these presents do make, constitute and appoint GLENN GERALD WADDELL, as my true and lawful attorney in fact (hereinafter sometimes referred to as my "attorney"), for me from time to time and in my name, place and stead to do the specific acts hereinafter specified on my behalf as if I were personally present, hereby intending to give to my said attorney the power to act for me in this limited capacity:

To sign documents, make representations regarding, revise agreements or prices, and take any and all actions necessary to complete and consummate the establishment of an equity line of credit on my residence at 16 Lake Providence Lane, Leeds, AL 35094 with Servis1st Bank. I hereby authorize any third party to release to my attorney in fact such information on my behalf as is necessary to accomplish such acts. This power of attorney is provided so that the establishment of the equity line of credit on my residence can proceed without the necessity of my presence at the closing.

I may at any time revoke this power of attorney, but it shall be deemed to be in full force and effect as to all persons, institutions and organizations which shall act in reliance thereon prior to

It is not my intention by setting out specific powers and authorizations to limit or cut down the broad powers given herein but to clarify and support such gifts of power by expressly giving and granting unto my said attorney the full power to execute and deliver agreements, instruments or documents of any kind and for any purpose deemed necessary or proper by my attorney to carry out the acts herein authorized.

ARTICLE III
AUTHORIZATION TO RELEASE
INFORMATION TO ATTORNEY

Any institutions, persons, firms or corporations may act in reliance hereon and shall be fully protected even though the said attorney, substitute or associate may be dealing with himself or herself, as it is contemplated that such may be the case.

ARTICLE IV
GOVERNING LAW

This power of attorney shall be governed by the laws of the State of Alabama.

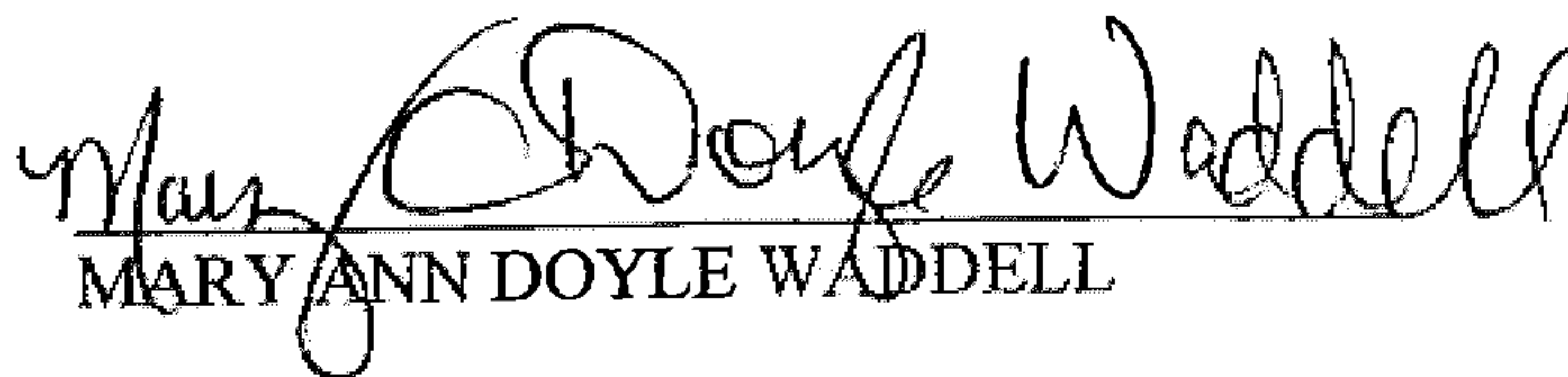
ARTICLE V

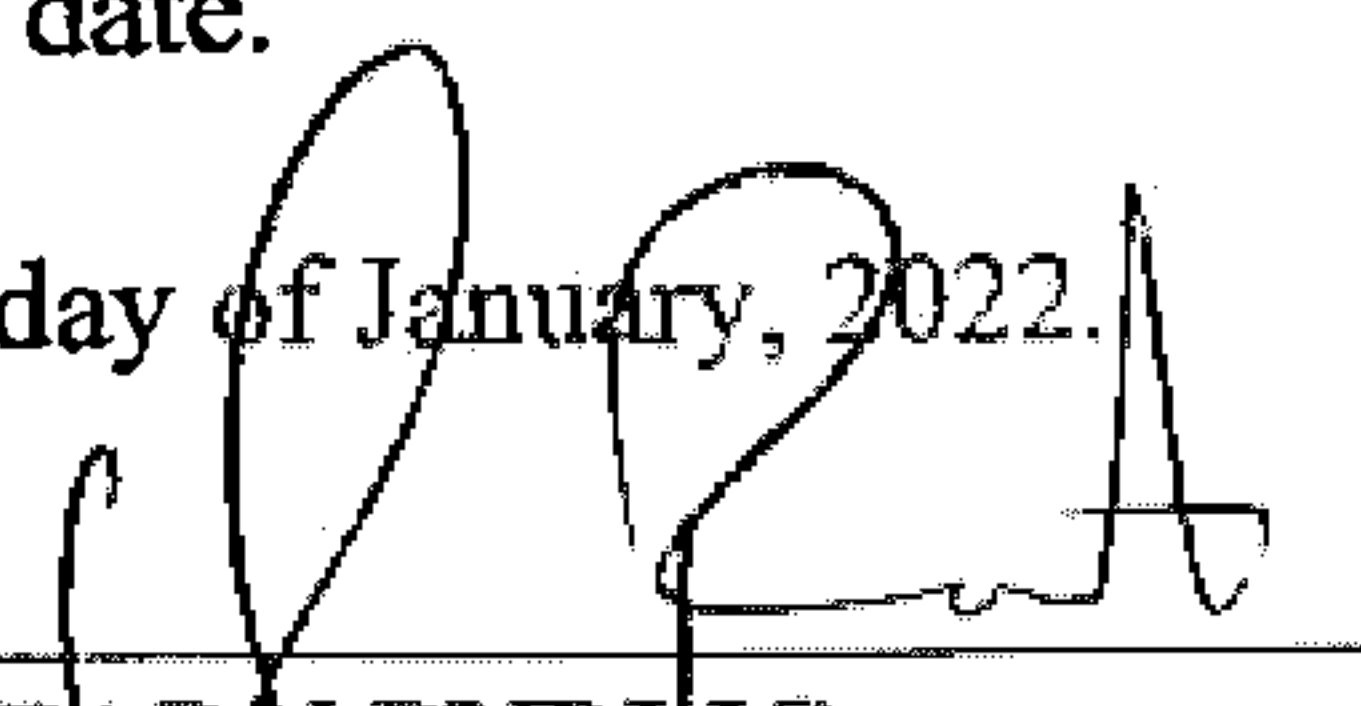

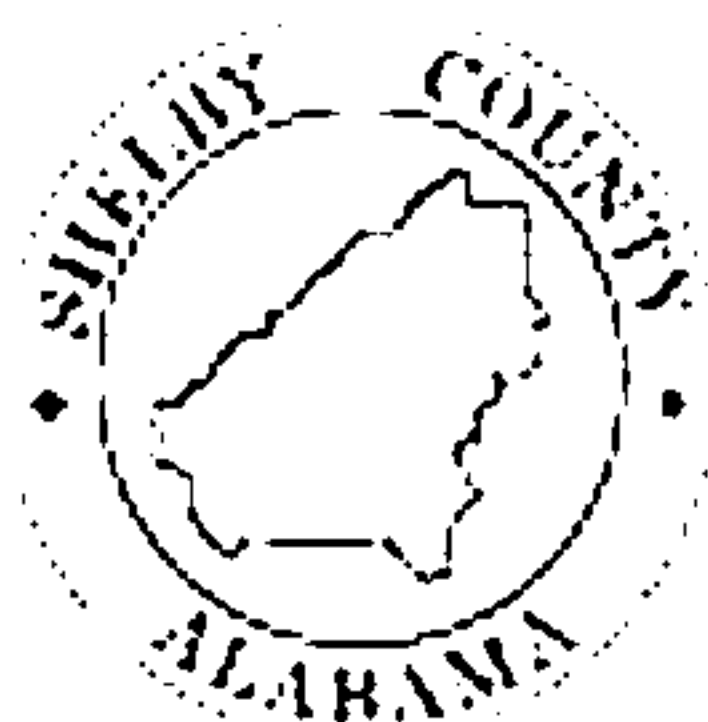
