Dutil and Kimiko Dutil, Husband and Wife** (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **John J. Santamour, III and Marie Leech**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

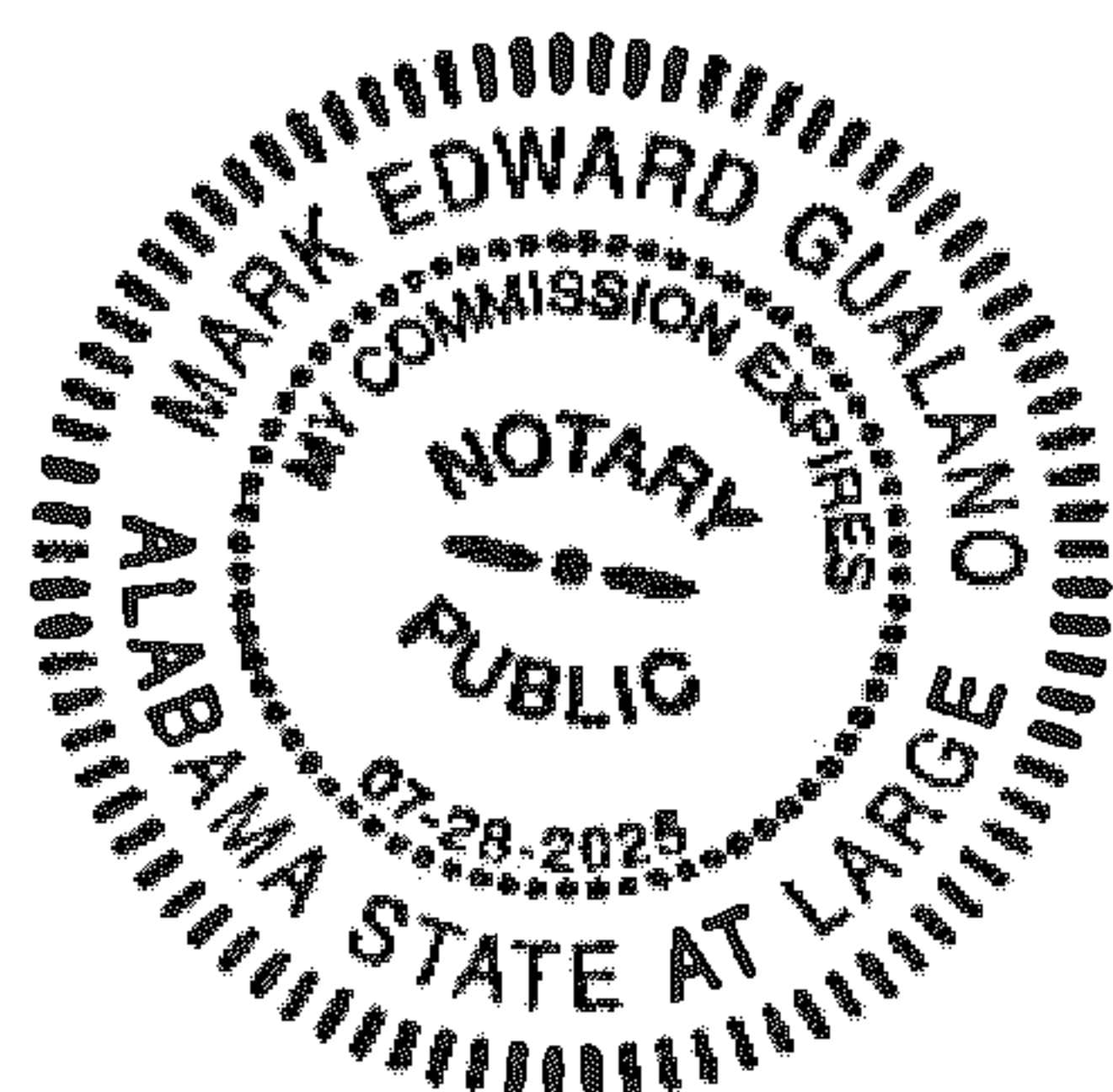
