
No part of the homestead of the Grantor herein or his spouse, if any.



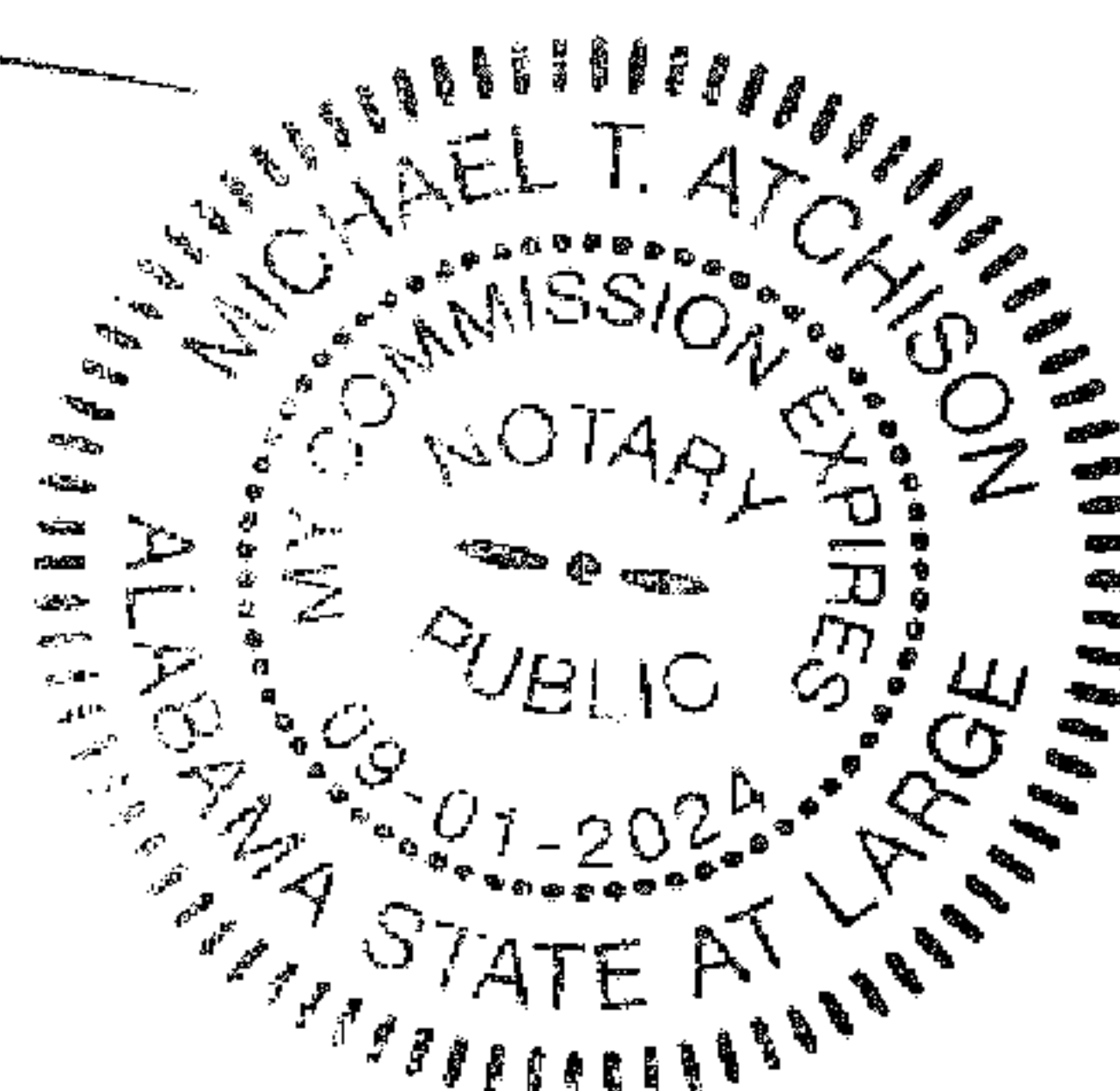
