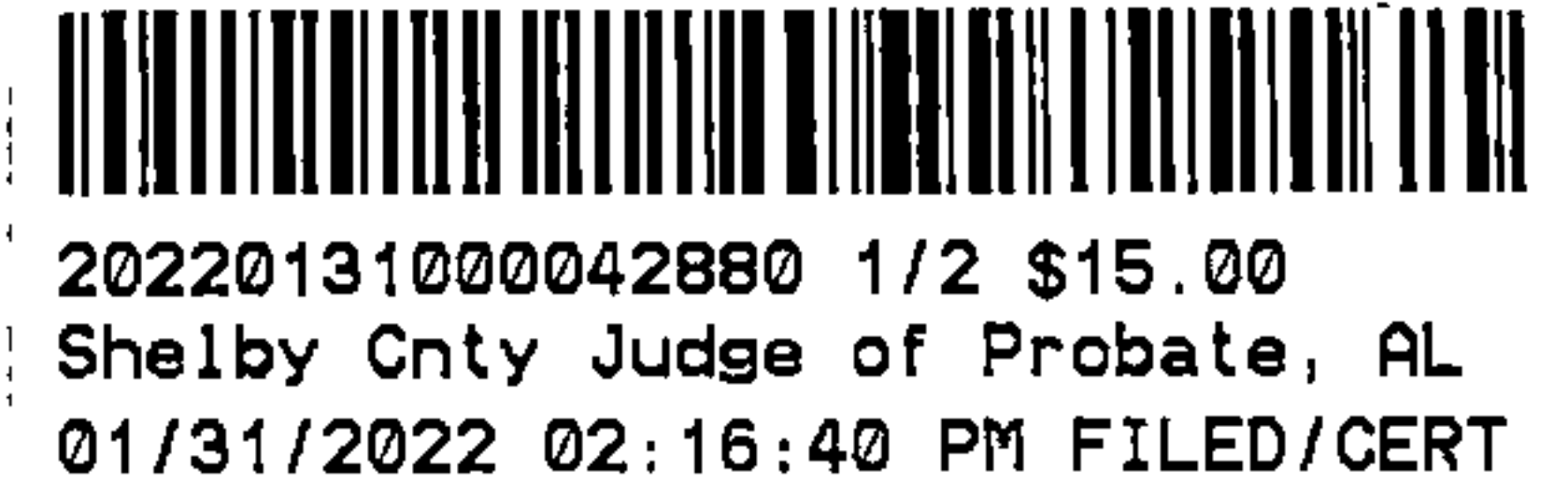


## Certificate of Trust






