For ad valorem tax purposes only, the address to the above-described property is 181 Pin Oak Drive, Chelsea, AL 35043.



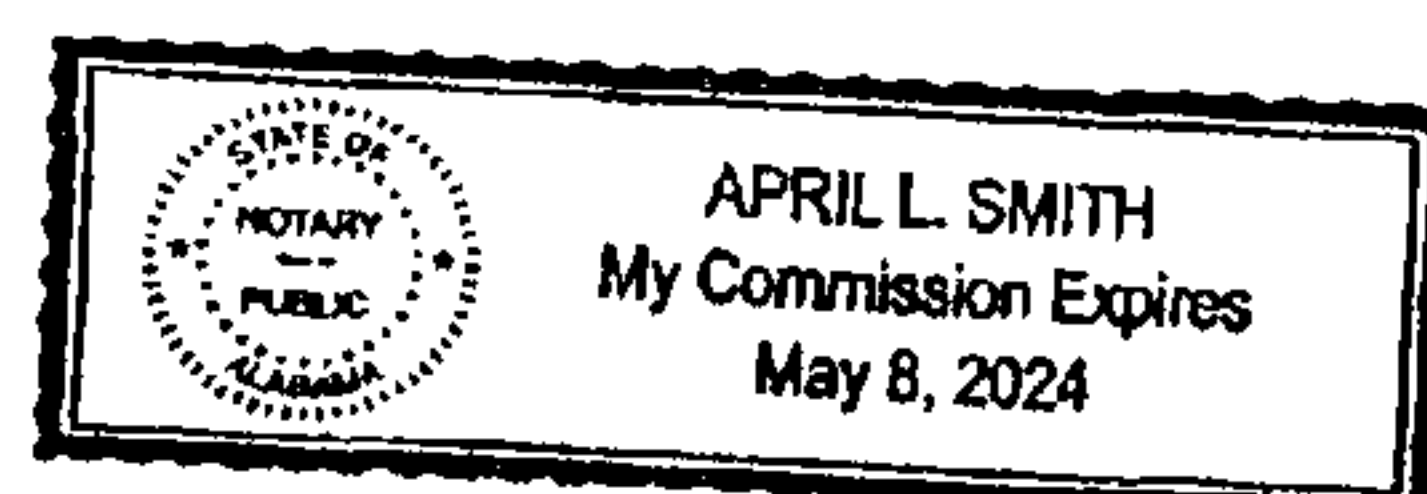
